RECORD: Iron Post 3 Ft long, 2 inch in diameter, 2-1/2 Ft in ground with Brass Cap

FOUND: 2-1/2" pipe badly deformed (as shown in Photo No 1) by being struck repeatedly by equipment in plowed field at appropriate bearing and distance from Wyoming/Colorado State Line Mile Post 5

SET: 5/8" rebar in middle of found 2 1/2" pipe as shown in Photo No.2 and set 1 1/2" Aluminum Cap on rebar inscribed as shown to perpetuate the identification of the Corner Monument as shown in Photo No. 3.

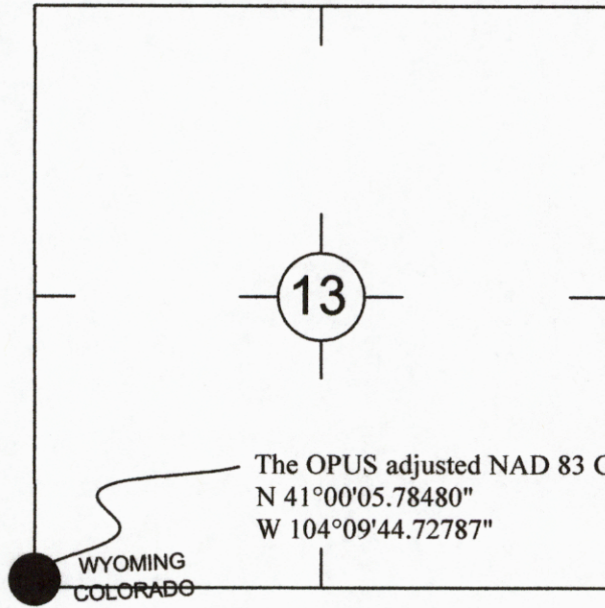
