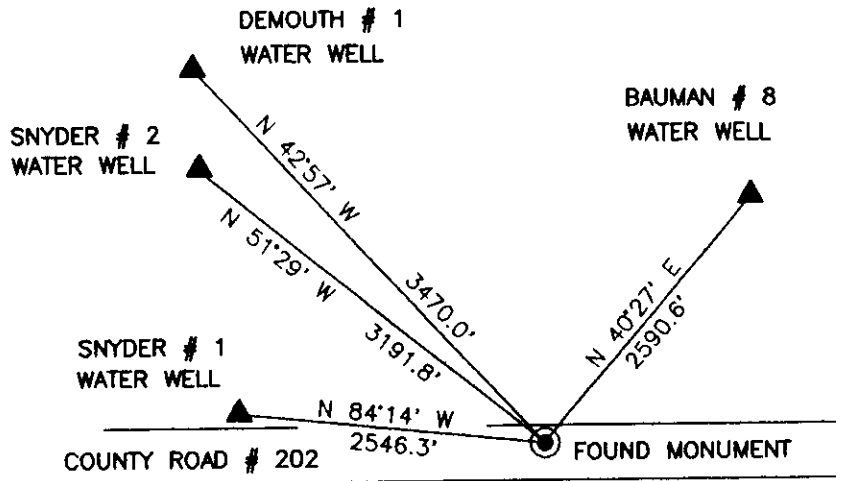

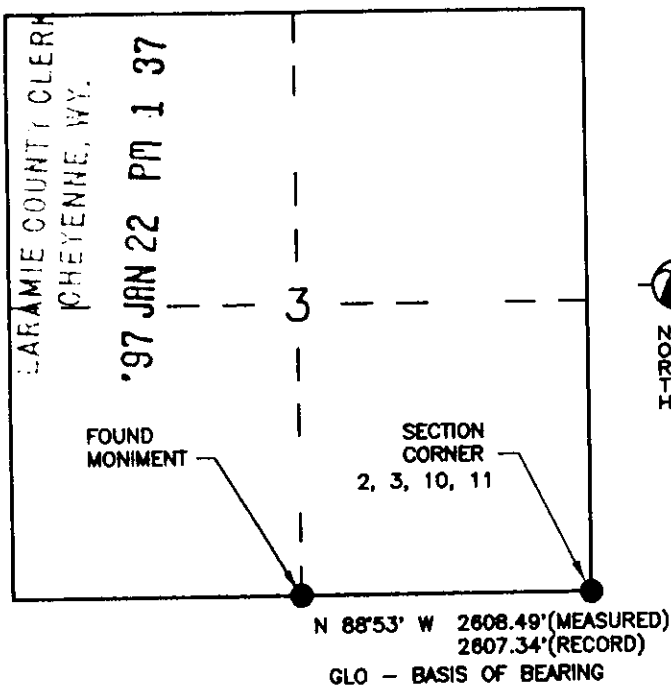

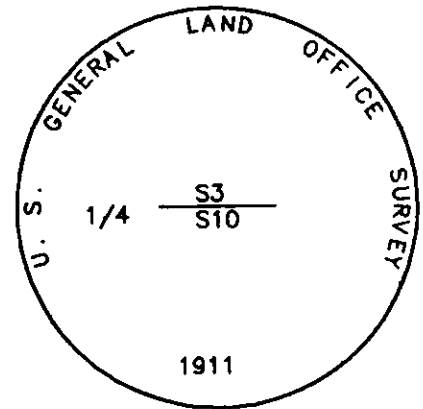
## Reference Locations

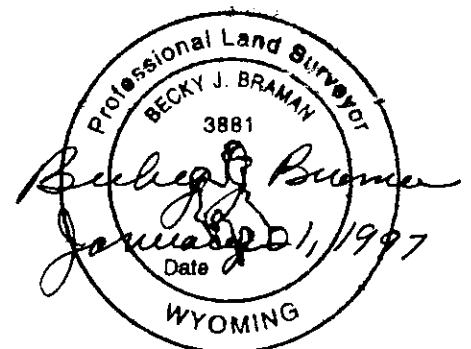
