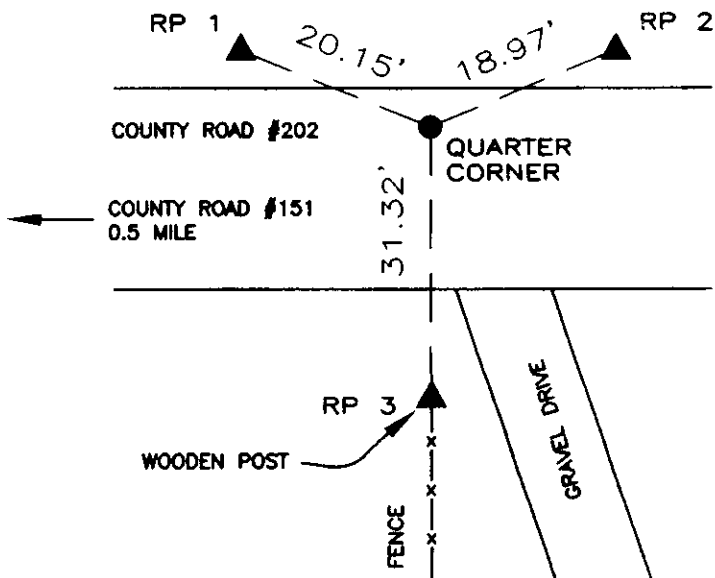

GLO RECORD: SET IRON POST 3' LONG, 1" DIA 2.5' IN GROUND WITH MARKED BRASS CAP

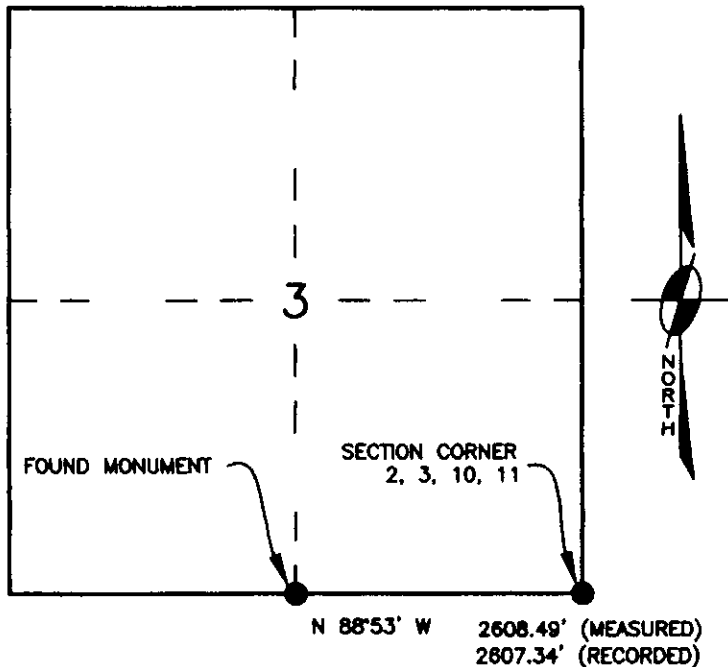
SET: INSTALLED 3" ALUMINUM CAP ON 1" PIPE - SEE MONUMENT INSCRIPTION

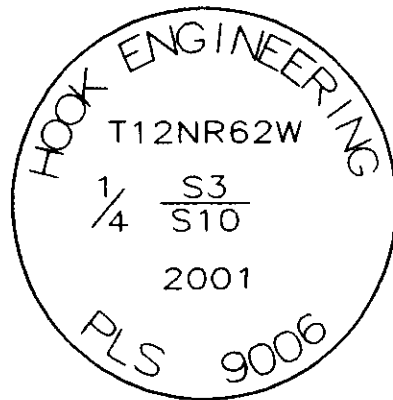
Reference Locations
