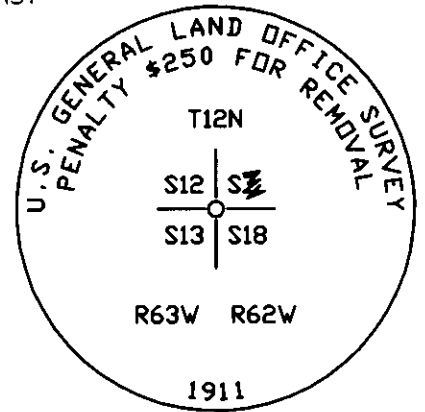
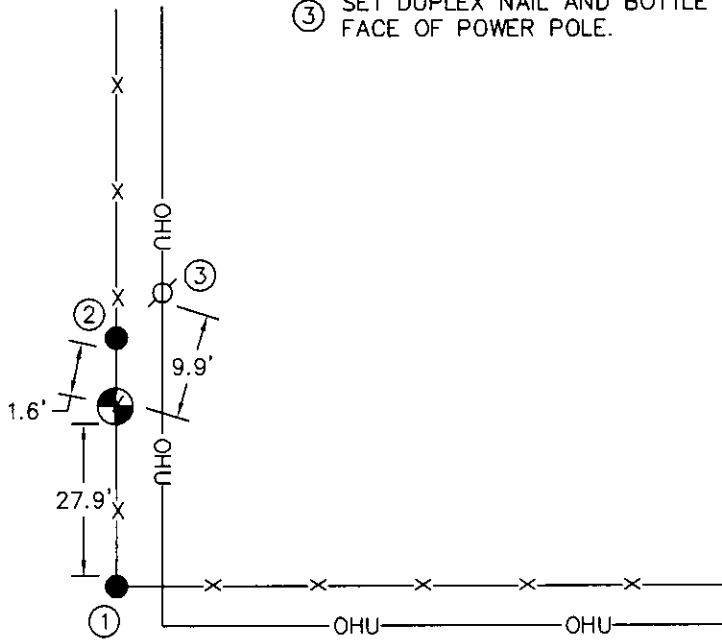

MONUMENT FOUND: FOUND 3" PIPE WITH 3 1/4" BRASS CAP STAMPED U.S. GLO 1911 AS SHOWN BELOW. MONUMENT WAS RECOVERED FLUSH WITH GROUND SURFACE.

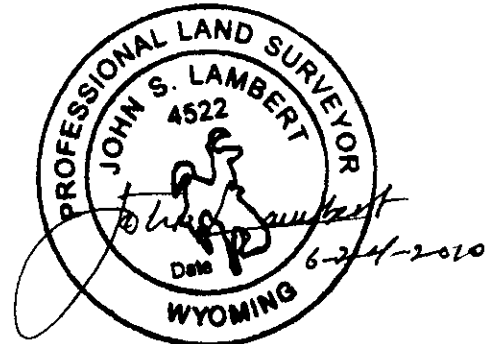
