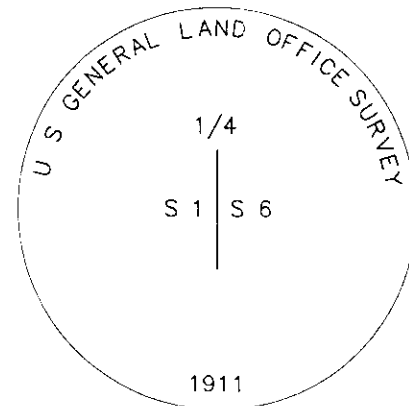

U.S.G.L.O. 1911 Dependent ReSurvey Record: Set a iron post, 3 ft. long, 1 inch diam., 2-1/2 ft in the ground, for 1/4 sec. cor. and mark on the brass cap on the post 1/4 S 1 on the W. and S 6 on the E. half.

Found a USGLO standard 2-1/2" Brass Cap on a 1" iron pipe 0.5' above ground, inscribed as shown below.

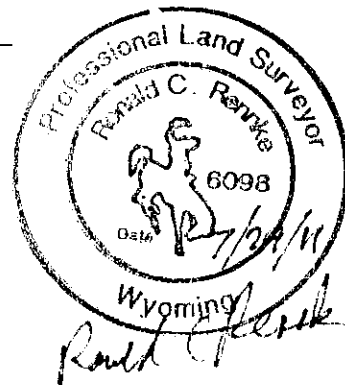
