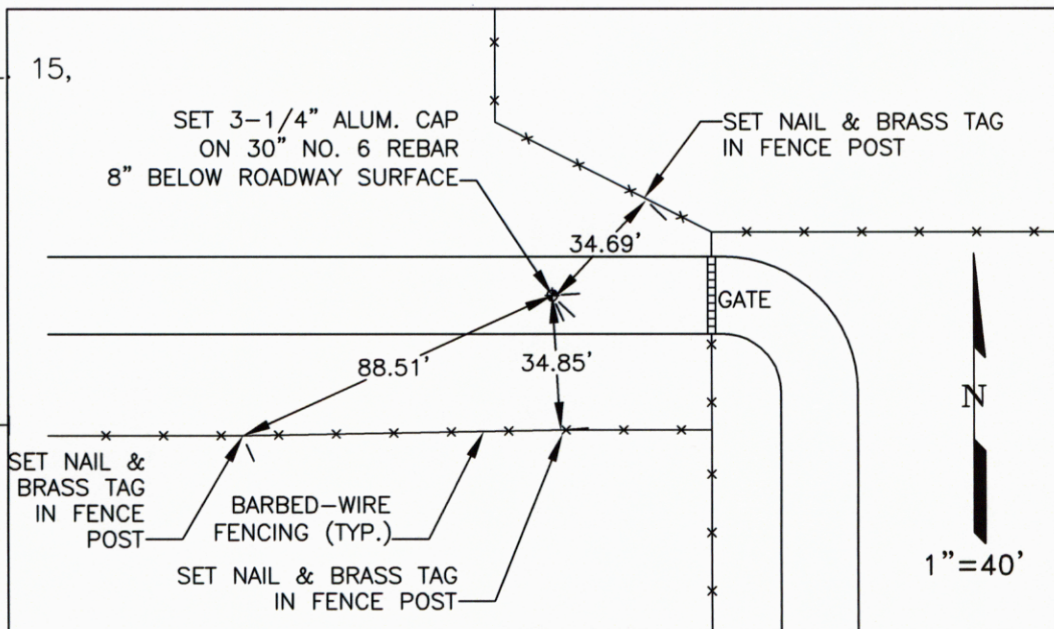

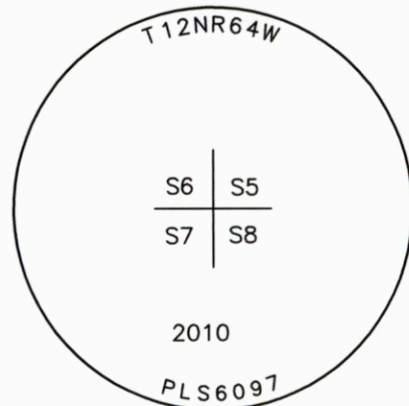


LOCATION SKETCH

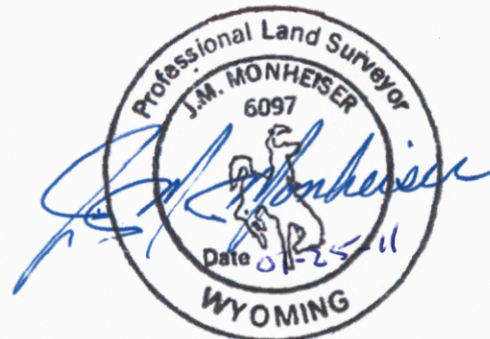
