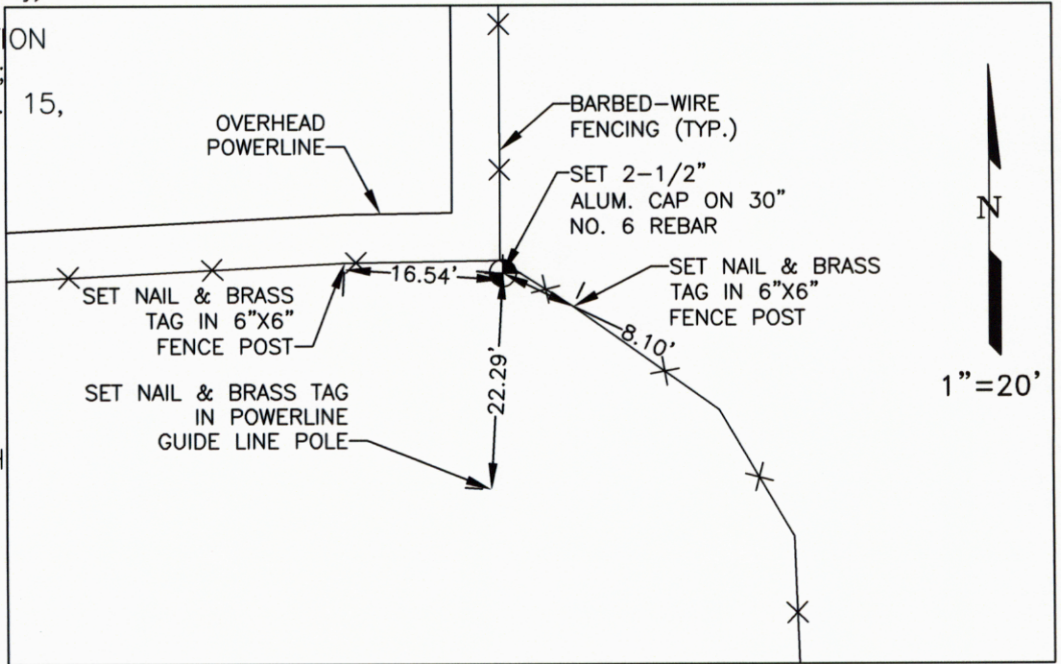

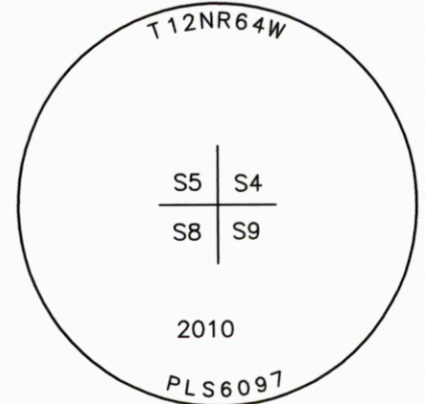
LOCATION SKETCH

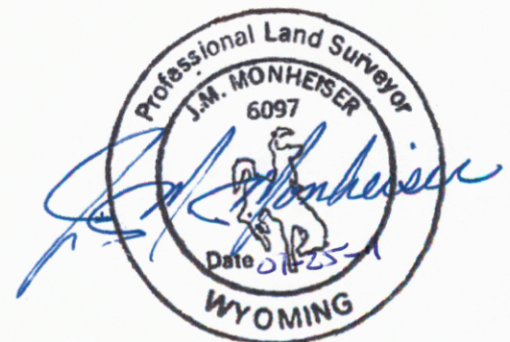
