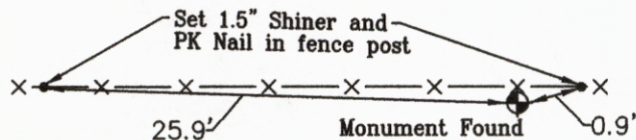

MONUMENT AND ACCESSORIES ESTABLISHED: Set PK nail with 1.5" washer in fence post 0.9' East and 25.9' West of corner.

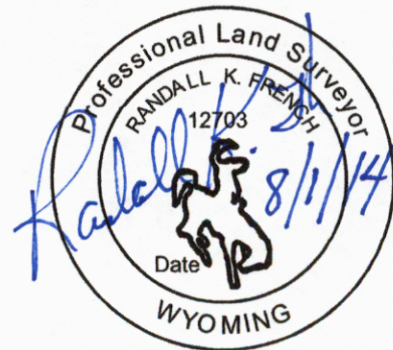
