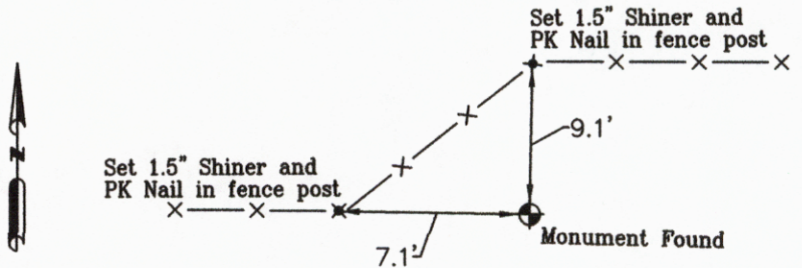
LOCATION: Mile Marker 24, S. 14, T.12N., R.64W., 6th P.M., Laramie County, Wyoming.

FOUND: 3.25" Brass cap on steel pipe.

MONUMENT AND ACCESSORIES ESTABLISHED: Set PK nail with 1.5" washer in fence post 9.1' North and 7.1' West of corner.
