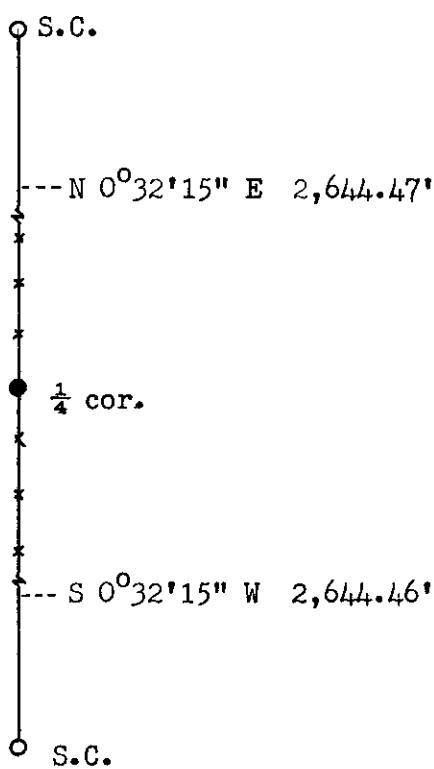
DESCRIPTION OF CORNER EVIDENCE FOUND, AND ORIGINAL RECORD (if known)

LOCATION $\frac{1}{4}$ S.12 S. 7 T.12N. R.66W., R.65W. 6th P.M.	Found 2" x 4" x 9" Granite stone with " $\frac{1}{4}$ ", lying on top of ground, 50 feet NE (downslope) of re-established corner.  Corner re-established by single proportionate measurement.  G.L.O. record - Boulder stone, 10 x 8 x 7

DESCRIPTION OF MONUMENT AND ACCESSORIES ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

At the corner: Set a  $1\frac{1}{2}$ " dia. x 30" long iron pipe with brass cap.  
 Accessories: Raised small rock mound south of corner monument.  
 Left stone as memorial.
