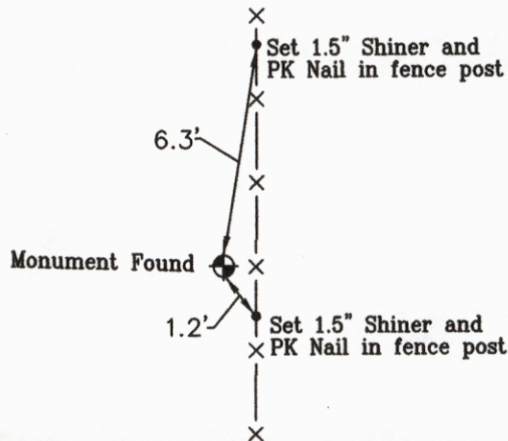
LOCATION: Southeast Corner, S. 12, T.12N., R.65W., 6th P.M., Laramie County, Wyoming.

MONUMENT AND ACCESSORIES ESTABLISHED: Set PK nail with 1.5" washer in fence post 6.3' Northeast and 1.2' Southwest of corner.
