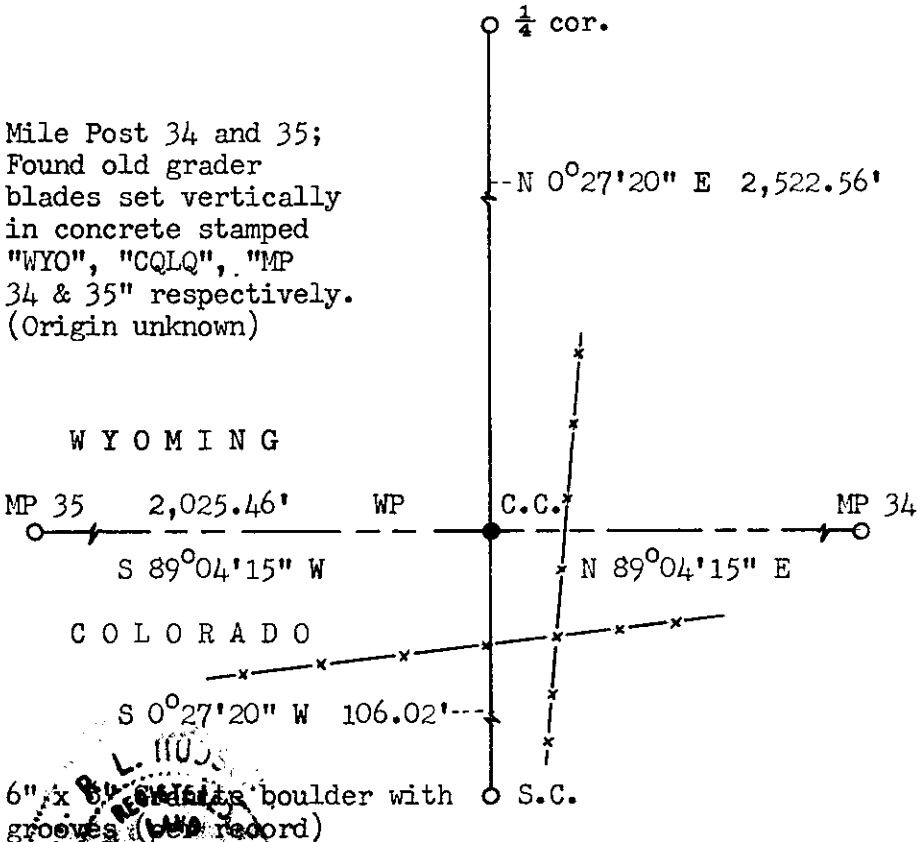

DESCRIPTION OF MONUMENT AND ACCESSORIES ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

At the corner: Set a 1½" dia. x 30" long iron pipe with brass cap.  
 Accessories: Set a 4" x 4" x 4' long Redwood post, scribed "WYOMING" on north and "COLORADO" on south, 3 feet west of corner monument.

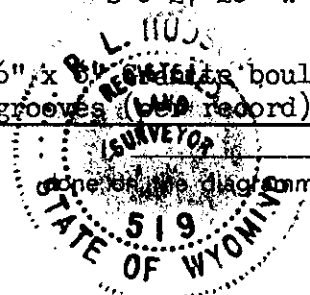
Mile Post 34 and 35;
