

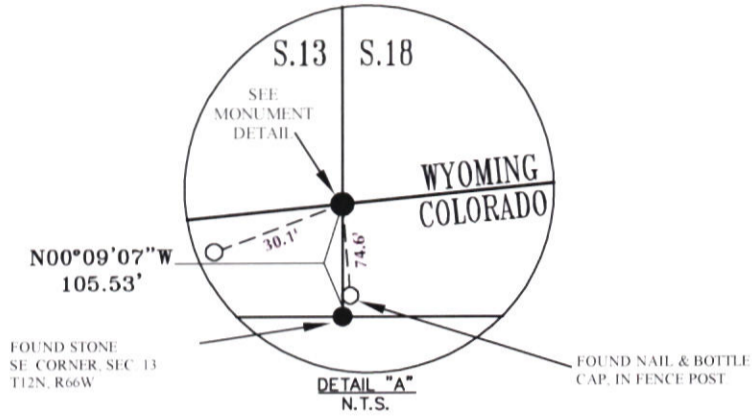

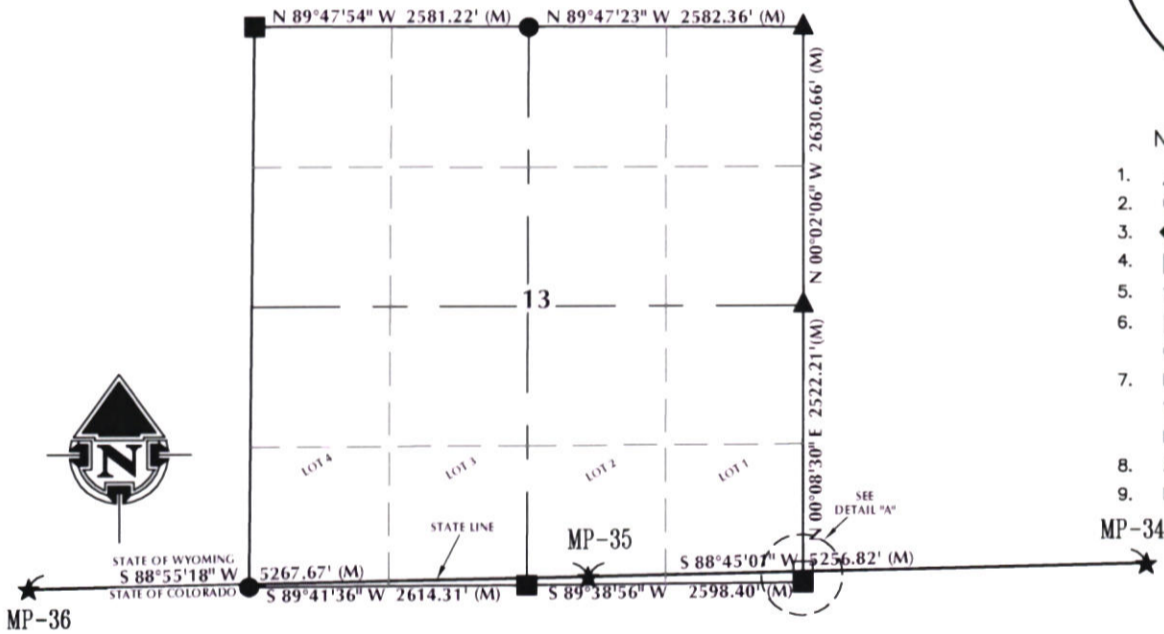
FOUND: Found 2" BRASS cap, stamped WYO LS 519, 3" above the surface of the ground, on 1.5" pipe;
