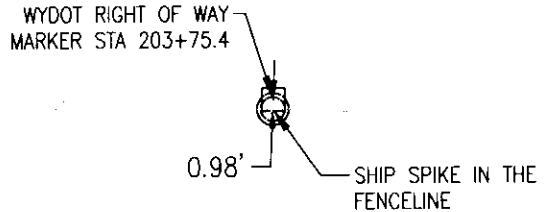

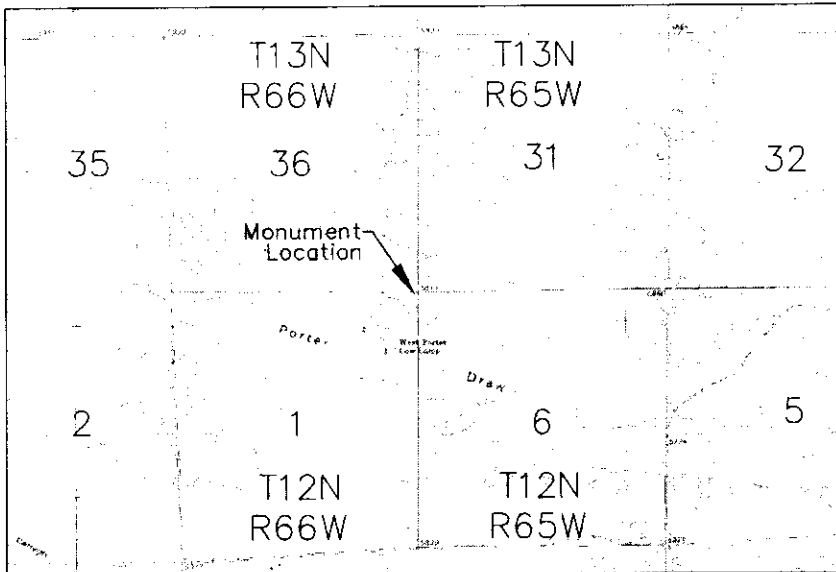

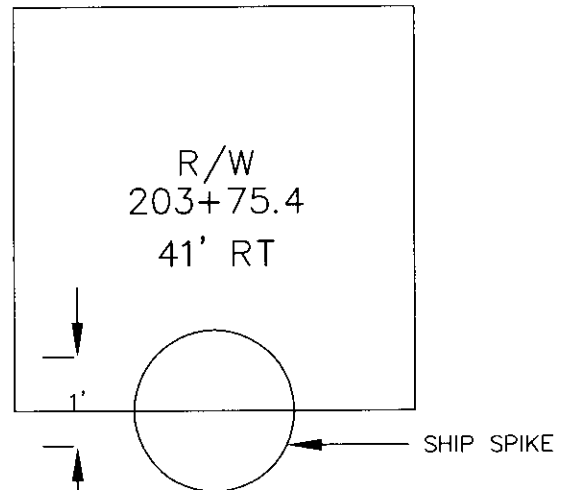


Location Sketch

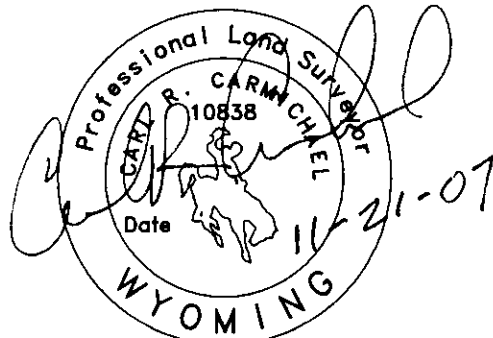
