LOCATION: Northeast Corner of Section 8, T12N, R66W, 6th Principal Meridian, Laramie County.

RECORD: GLO - Set a Conglomerate 20"x11"x3"

1982 - John Steil, LS 2500, found a granite stone firmly set, 10"x8"x6" above ground plainly marked with 5 notches on south edge and 4 grooves on east face. Set 3 ties.

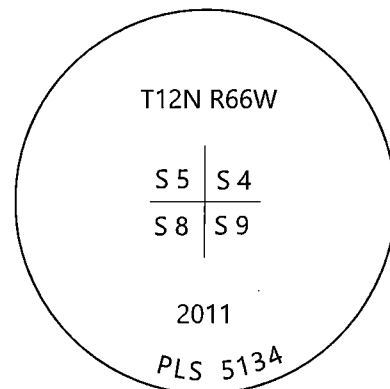
2006 - John Dolinar, LS 2608, found a 13"x10"x5" stone laying flat on the ground, 5 notches on the south side and 4 notches on the east side. Monument is located 3' north of an E-W running fence. (Measured 2645.7' to the SQ of Sec. 4, measured 2643.1' to the WQ of Sec. 4)

2010 - Randall Stelzner, LS 5134, found a 12"x9"x5" stone flat on ground, 4 scribed marks on top face lying in a different location than shown in the corner record filed by John Dolinar. Set a 2.5" aluminum cap on a 5/8" rebar calculated from field notes provided by John Steil. Original stone buried on east side of new monument. (Measured 2575.82' to the NQ corner of Sec. 8, measured 2642.20' to the EQ of Sec. 8)

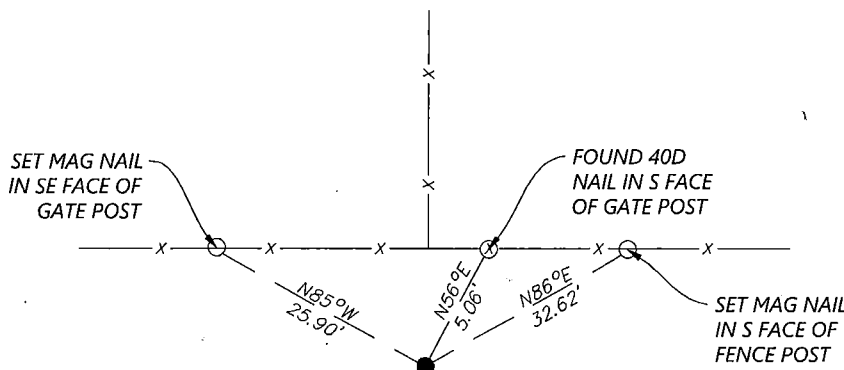
2015 - John Steil, LS 2500, completed a survey for Sec. 5 and found a 2" aluminum cap stamped "PLS 5134" for this corner. (Measured 2575.80' to the SQ of Sec. 5, measured 2642.30' to the EQ of Sec. 5)

RECOVERED: Westwood Professional Services recover the aluminum cap as referenced in previous monument records.

RESET: Accepting location of the monument as the correct location of the corner. Set additional ties as shown.
