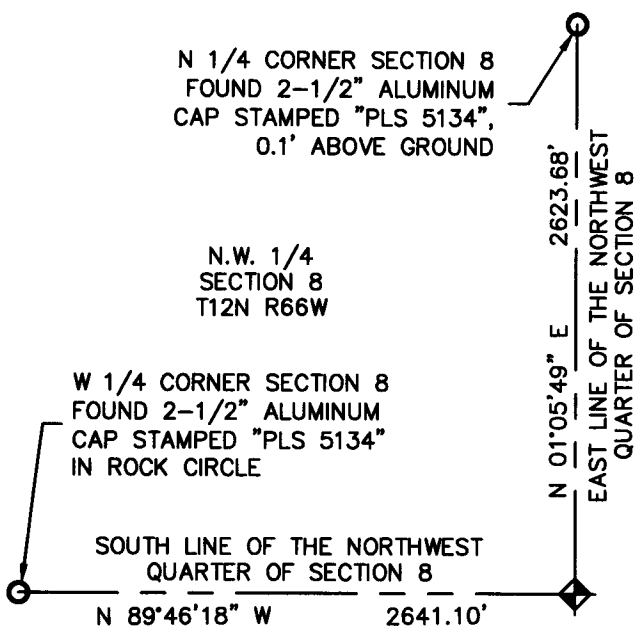

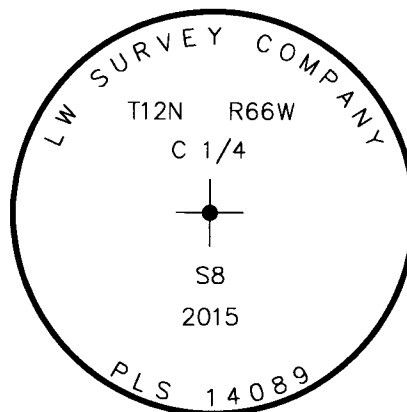

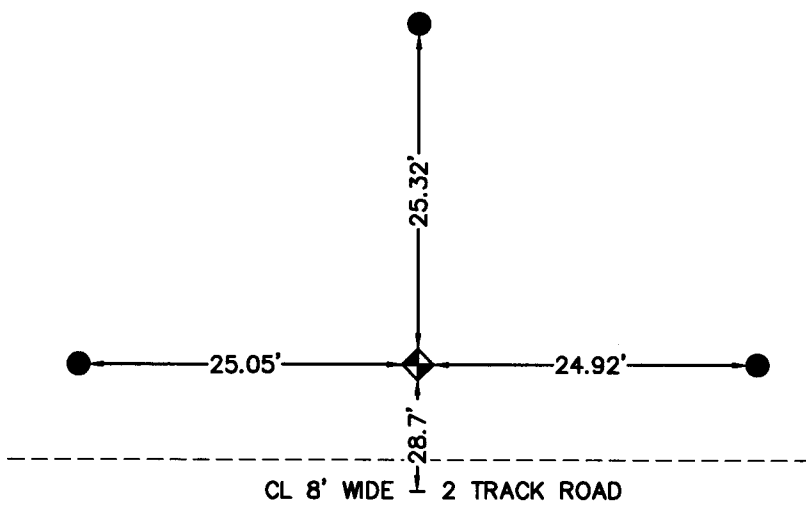
Monument Location

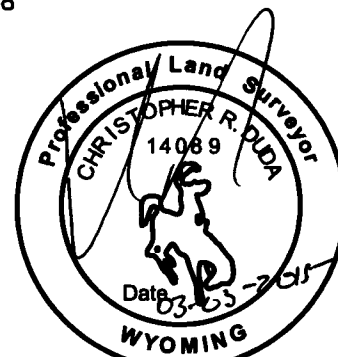
