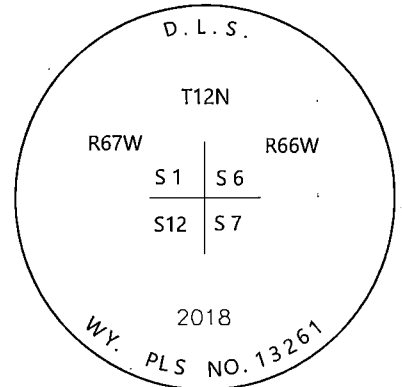
LOCATION: Northeast Corner of Section 12, T12N, R67W, 6th Principal Meridian, Laramie County.

RECORD: GLO - Set granite boulder 15" x 9" x 5"

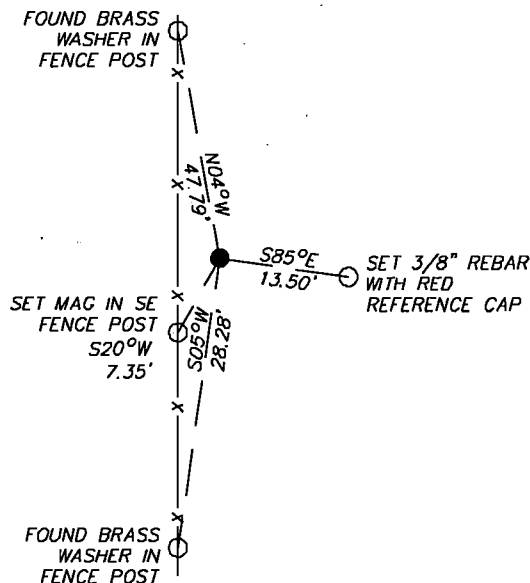

RECOVERED: 2019 - Westwood Professional Services found a 3.25" aluminum cap, approx. 2.5' east of north/south fence, as described by Albert Valletta Jr. and 2 ties.

RESET: Accepting location of the aluminum cap as the location of the corner and set additional ties as shown.
