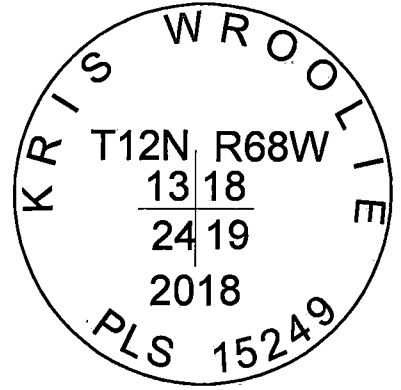

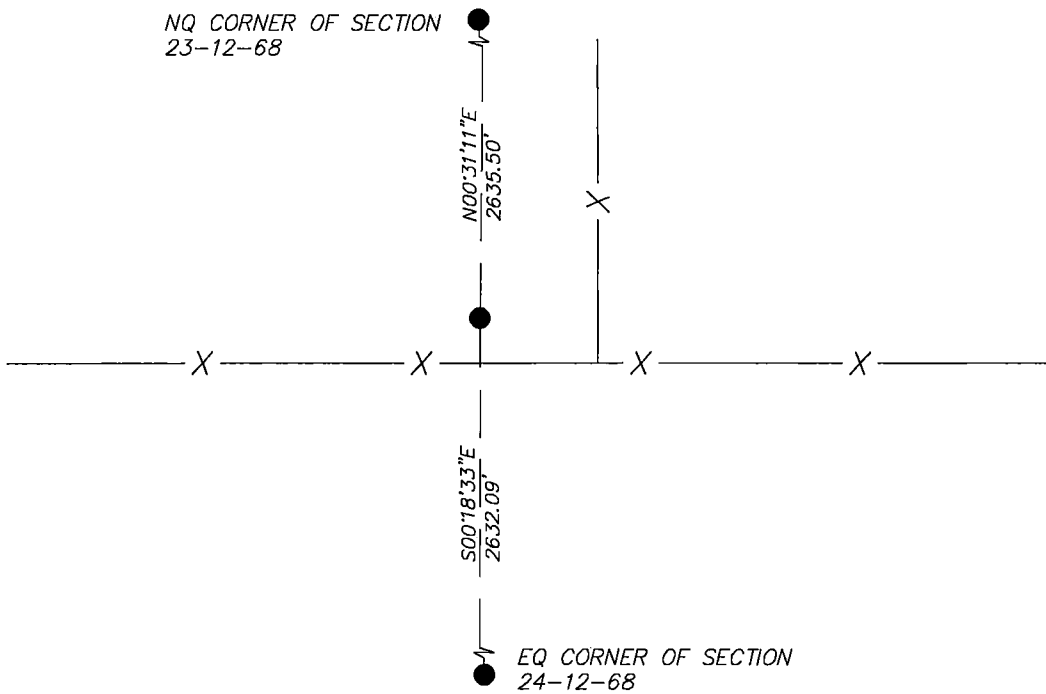
RECORD: GLO: Set boulder 14x10x10
