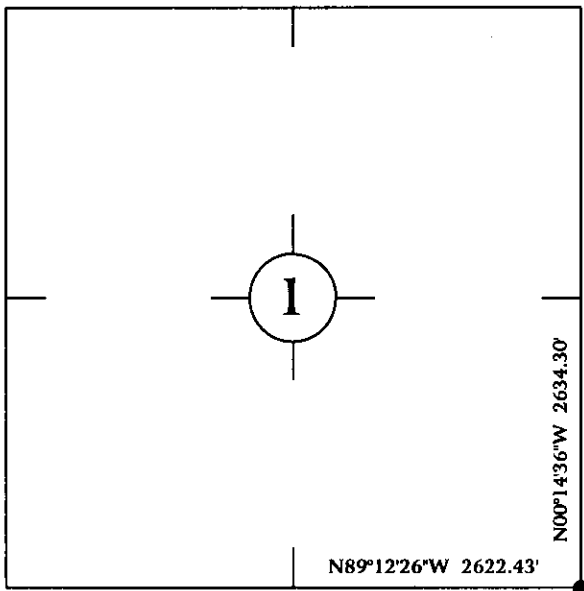

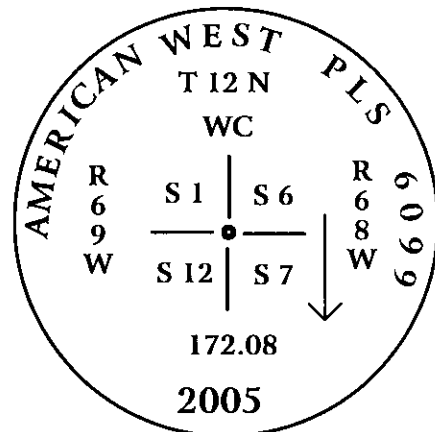
ORIGINAL CALL FOR 20" X 10" X 8" BOULDER STONE.

FOUND MOUND OF STONES AT TOP OF RIDGE. ACCEPTED MOUND AS WITNESS TO CORNER, AND SET 3/4" X 30" REBAR WITH 3 1/4" ALUMINUM CAP P.L.S. 6099 AT LOCATION OF STONES. TRUE CORNER FALLS ON STEEP SOUTH FACE OF HILL, WITH VISIBLE RECENT EROSION. SET TIES AS SHOWN BELOW.
