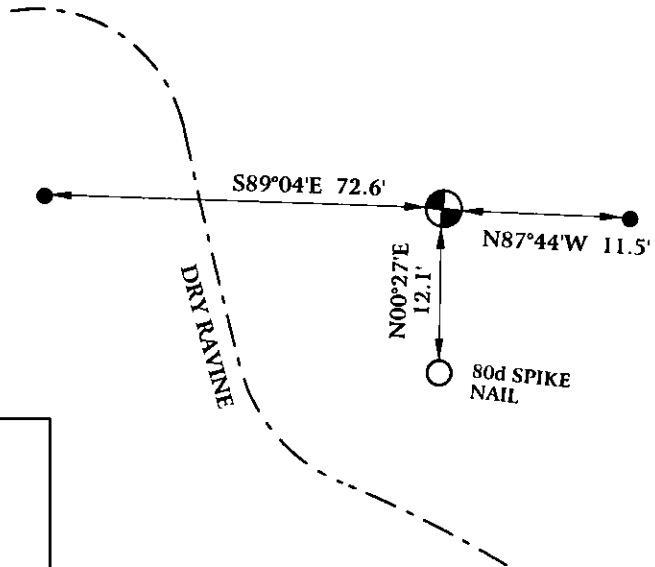
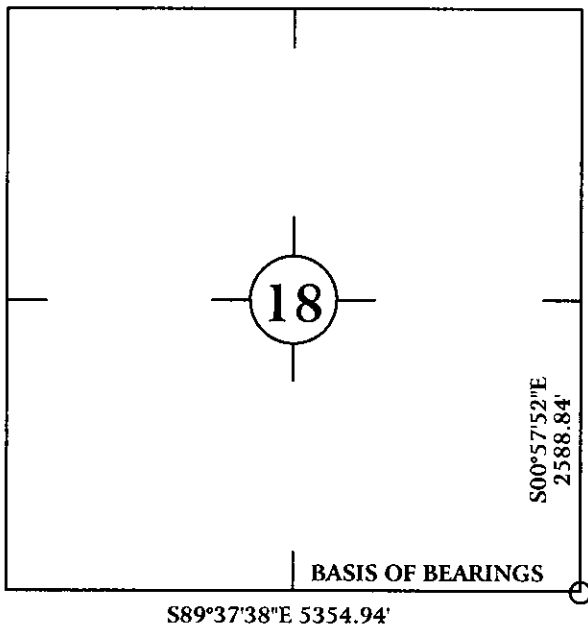

FOUND OLD EAST-WEST FENCE LINE, CLOSING COR., AND 1/4 CORNER TO SOUTH.

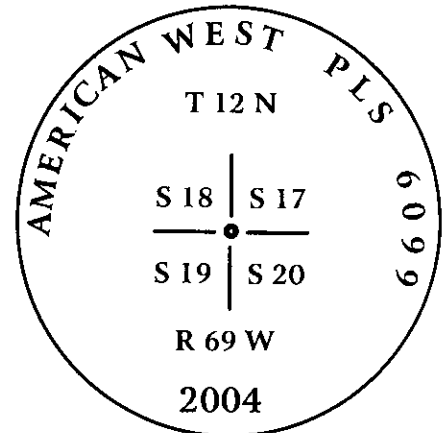
