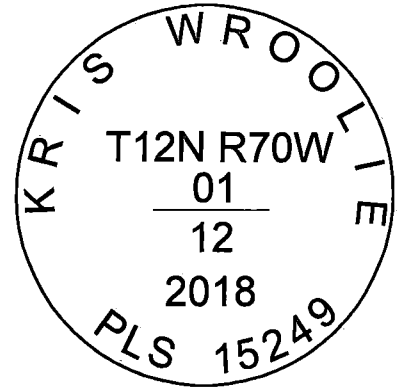

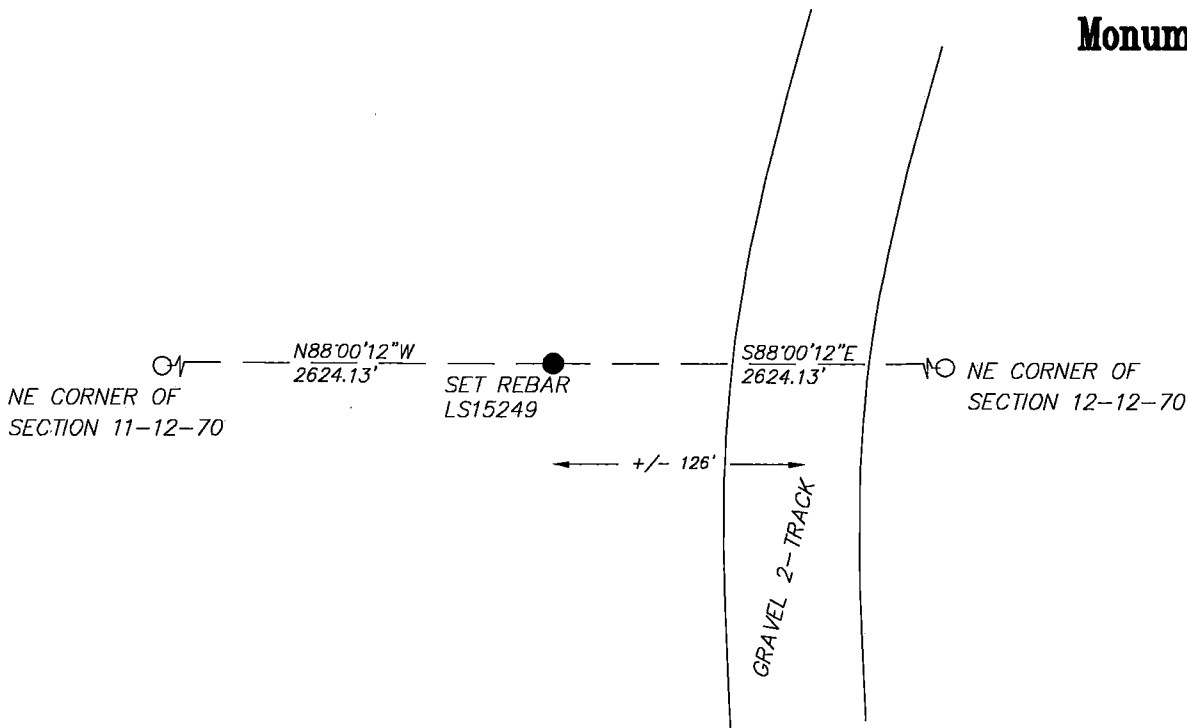
RECORD: GLO: Set a limestone 18x12x6 marked with a 1/4 on north side.

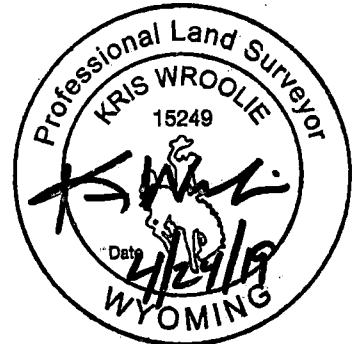
