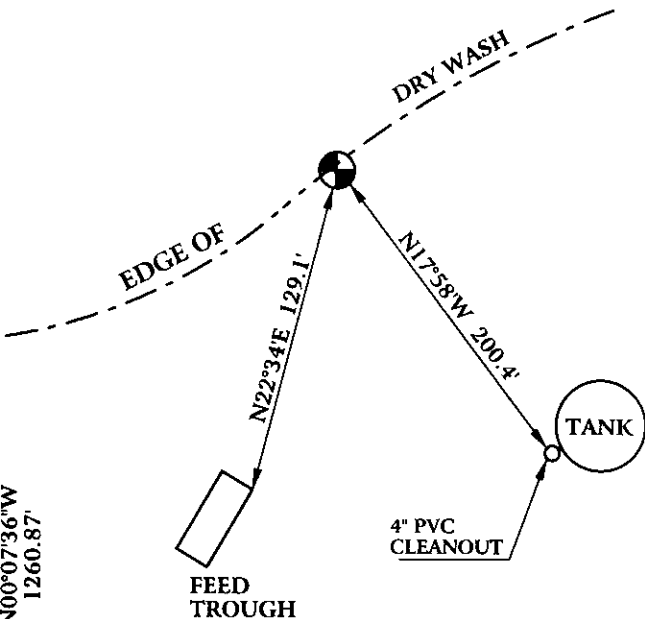
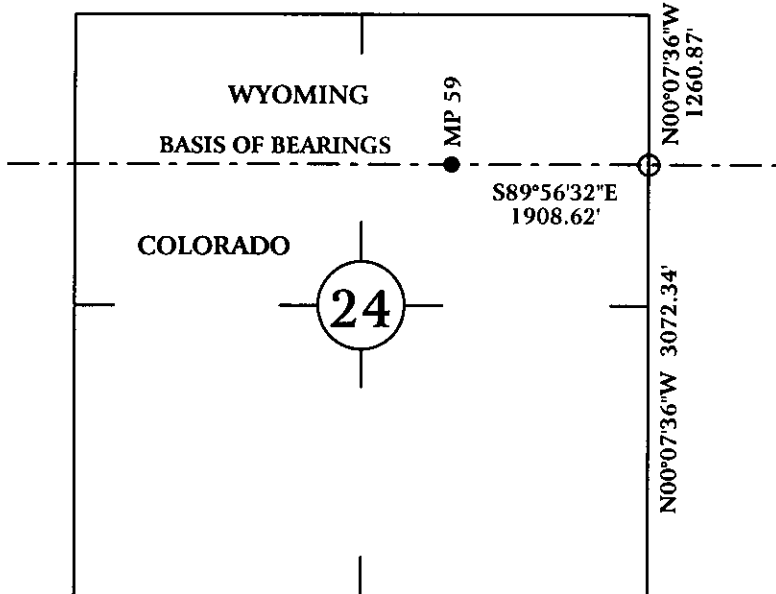

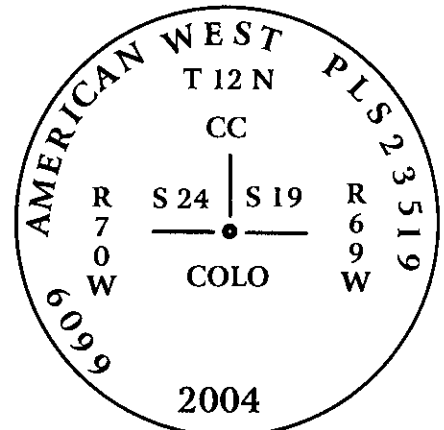
FOUND SECTION CORNERS NORTH AND SOUTH, MILE POST 56 TO EAST, AND MILE POST 59 TO WEST.

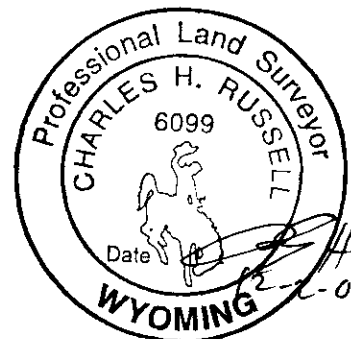
