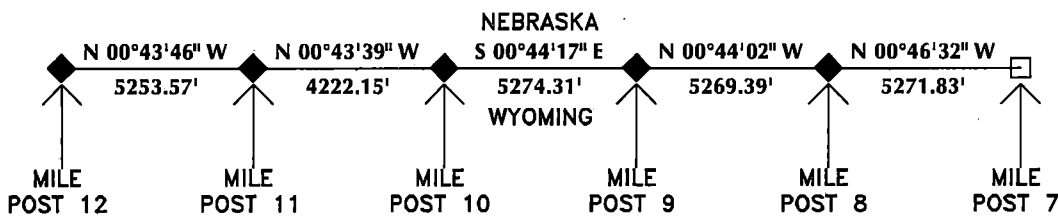

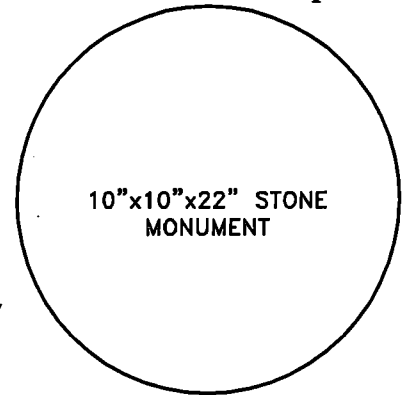
FOUND: Found a set stone monument 10x10x22 inches in size, with 7M on South face, WYO on West face and NEB on East face, located in a North-South fence line.
