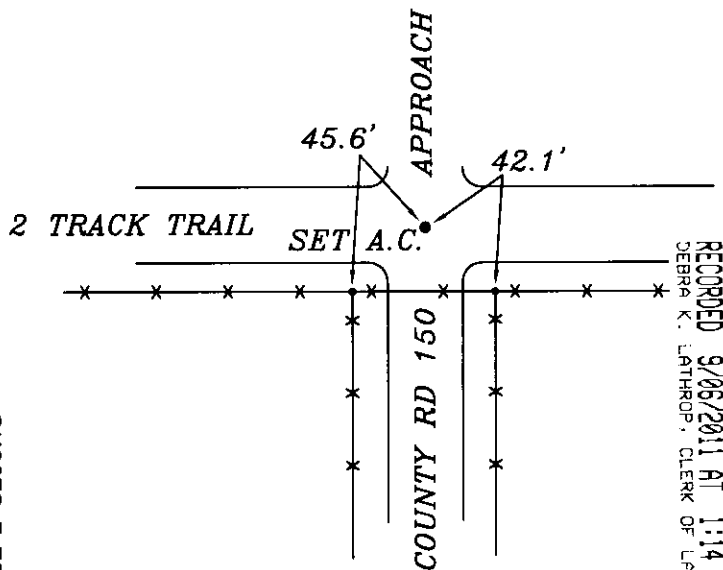
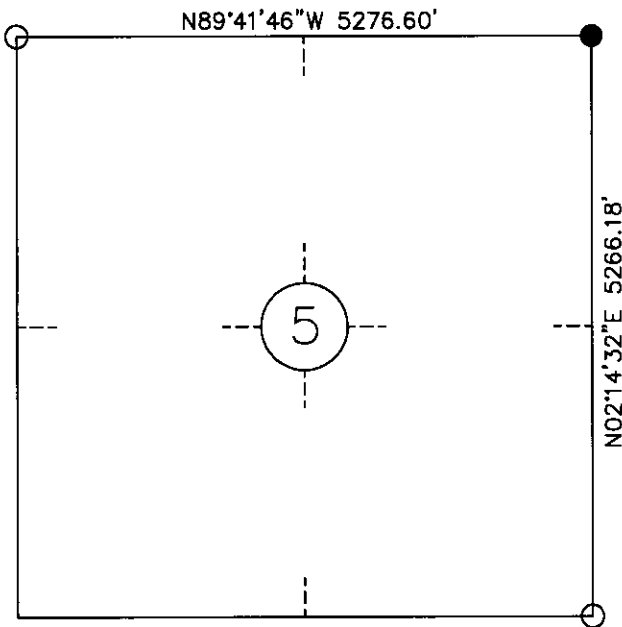

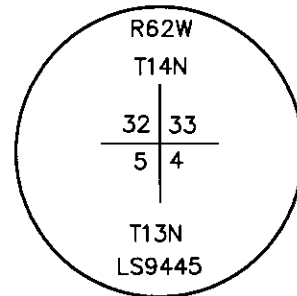
Monument Sketch
