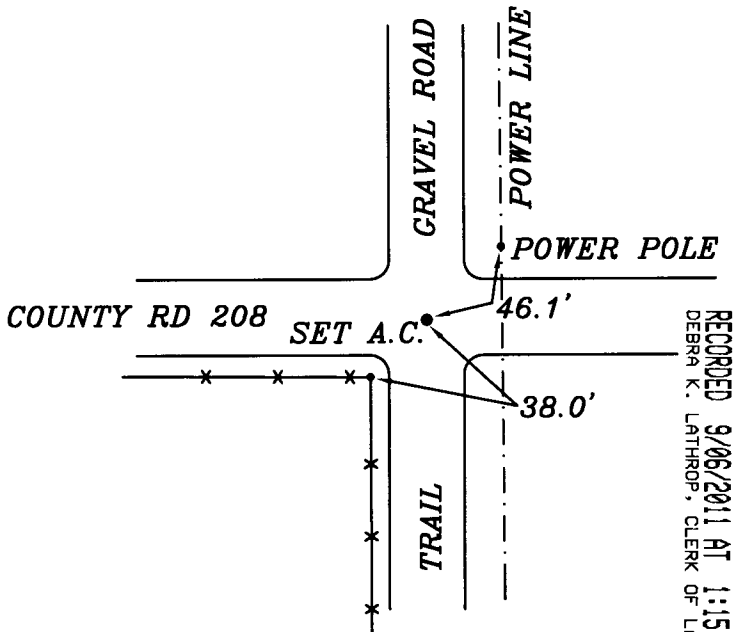
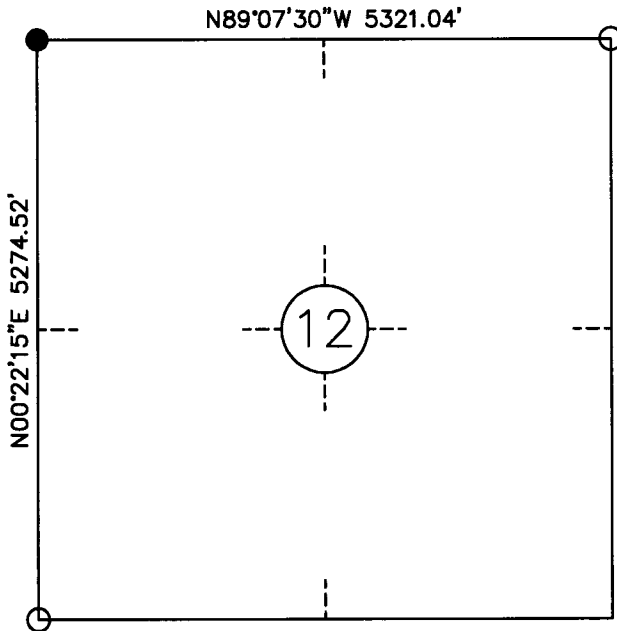

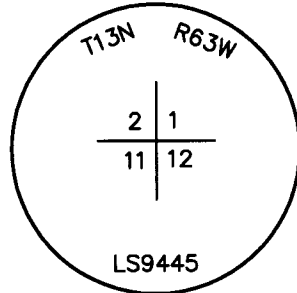
Monument Sketch
