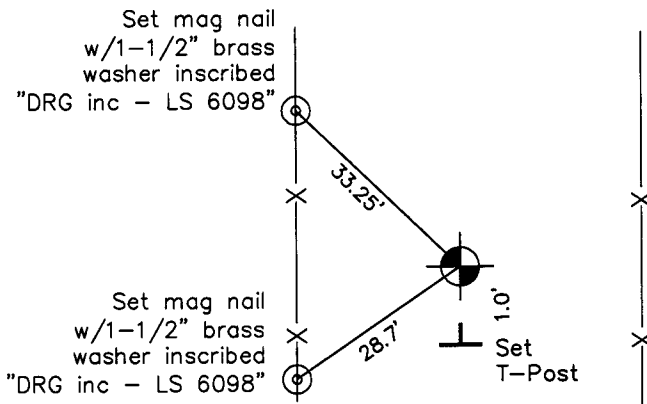

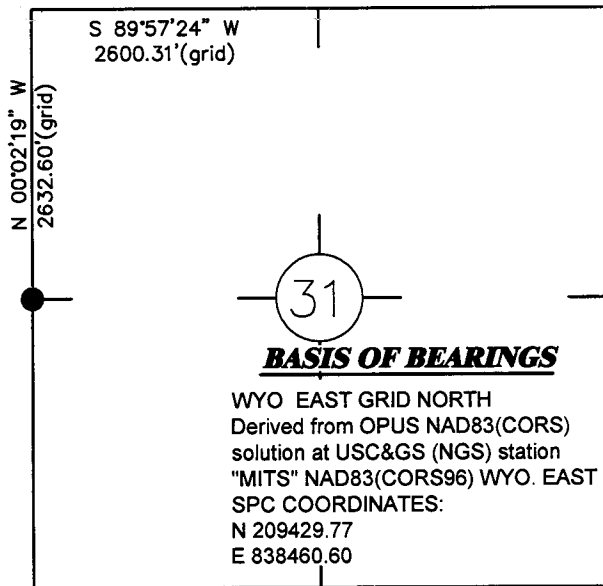

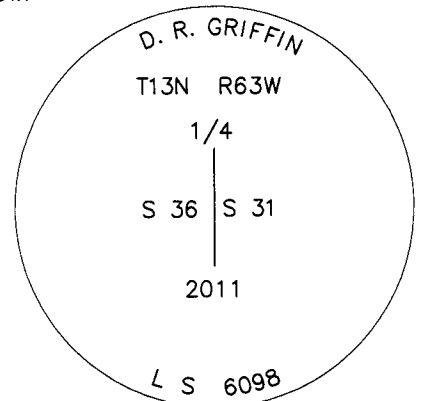


## Monument location

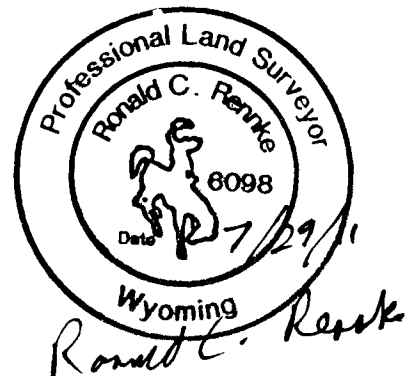
