**Found:** Did not find any evidence of original monumentation. Found two fence posts concreted in place and 80.00 feet apart in a latitudinal direction. After measuring to found reestablished corners north and found marked "wccr" stones south, I determined the concreted fence posts to be remaining evidence of county road witness corners of a undocumented survey.

**Set:** At the center latitudinal position of the found concreted fence posts and 40.00' north, I set a no. 5 x 24" rebar with 2 1/2" aluminum cap marked as noted below, 0.1' below the asphaltic roadway surface.

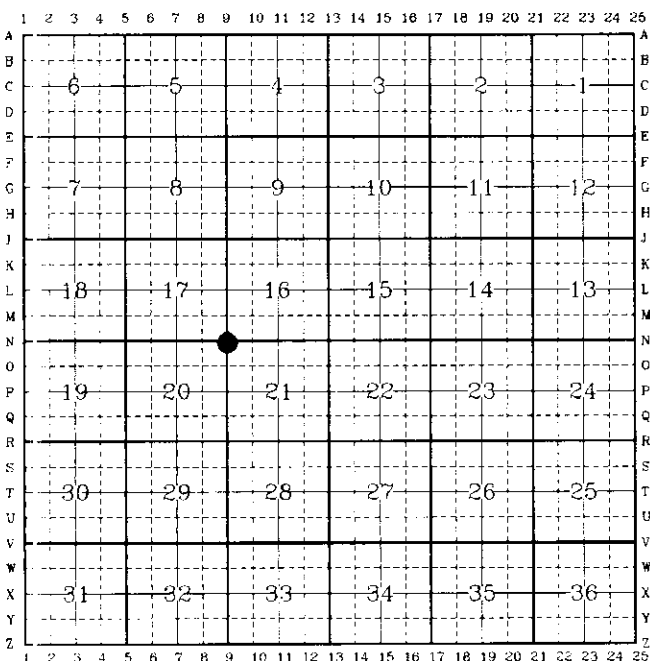

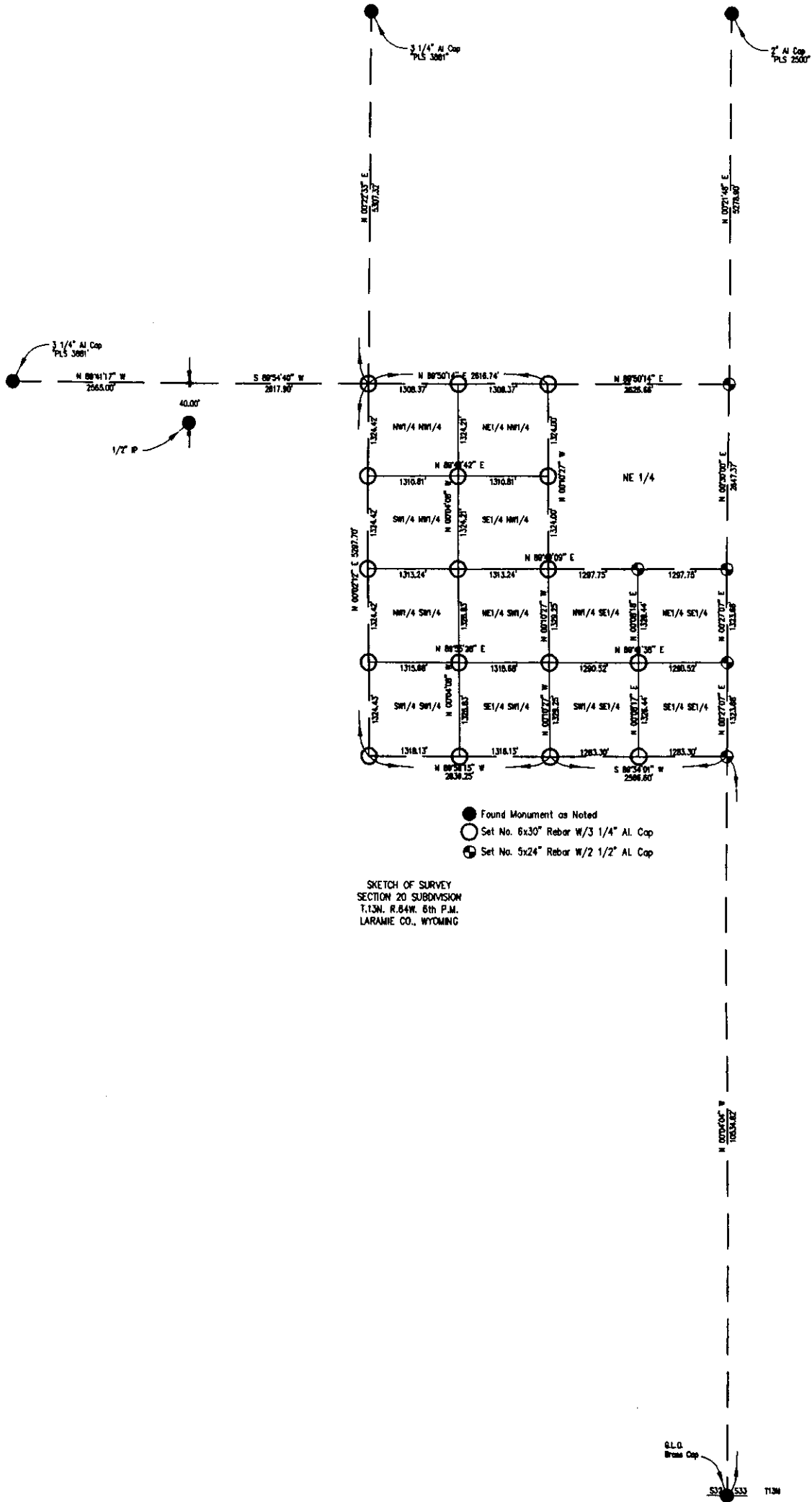
