Set: At 40.00 feet south and 40.00 feet easterly of the found WCCR stone I set a No. 5 x 24" rebar with a 2 1/2" aluminum cap marked as noted below, 0.1' below the asphaltic roadway surface of Campstool Road.

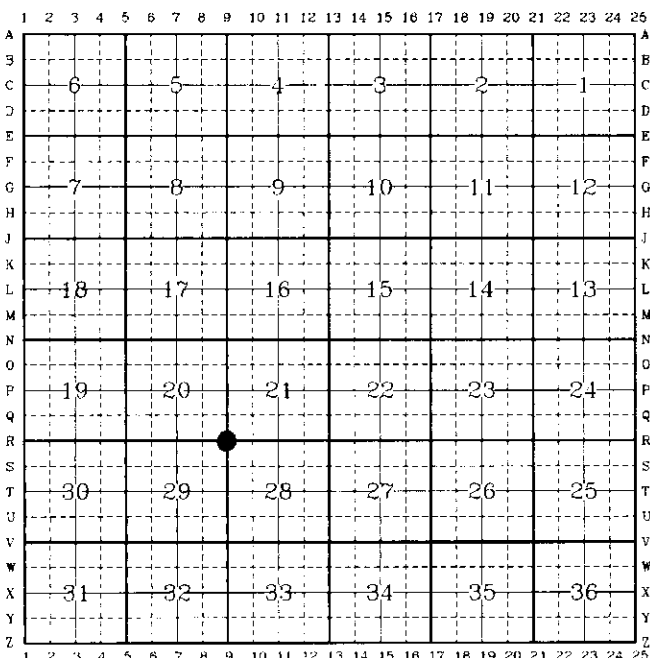

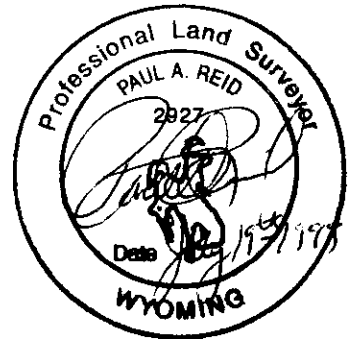
CROSS INDEX DIAGRAM

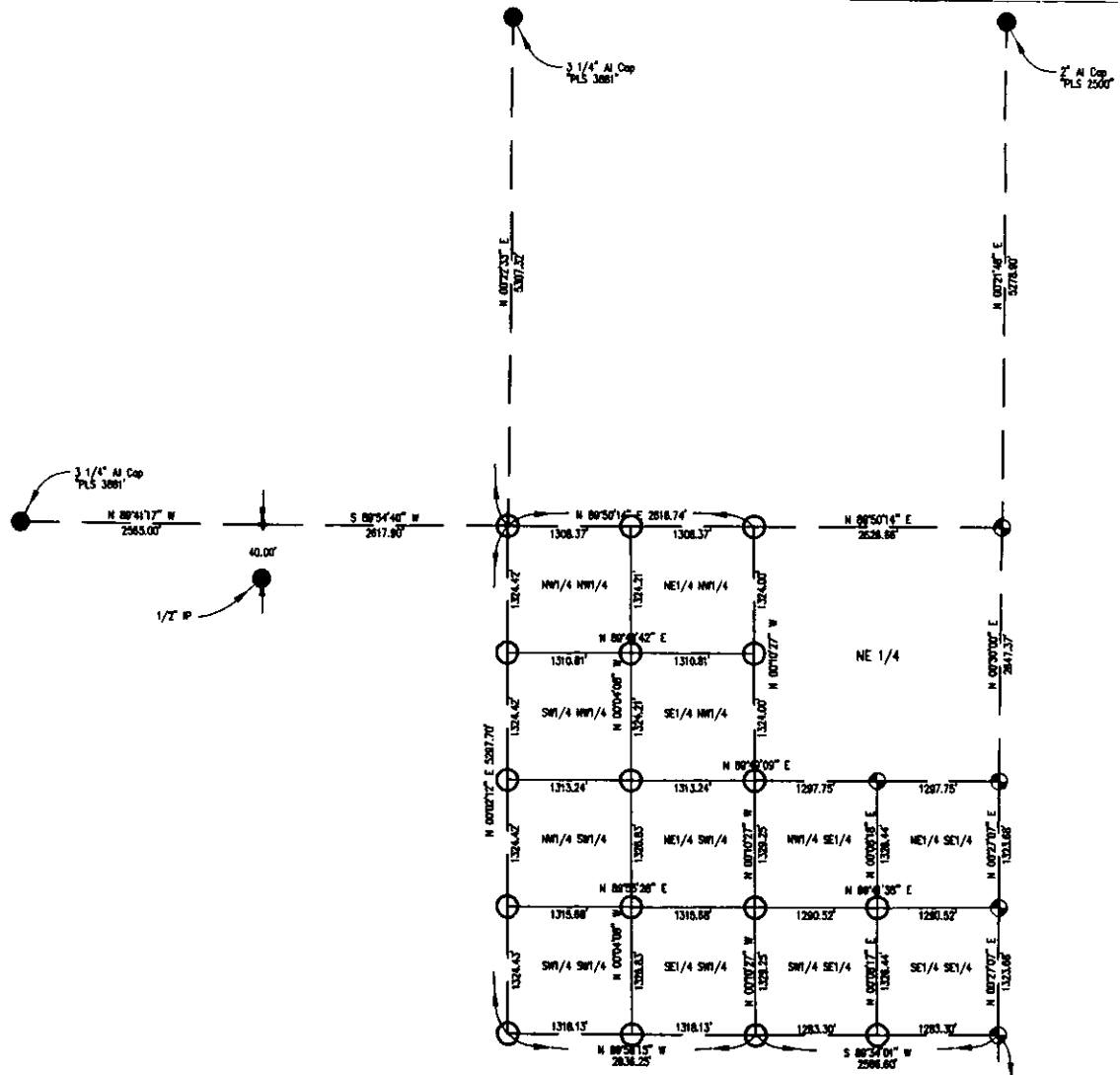
