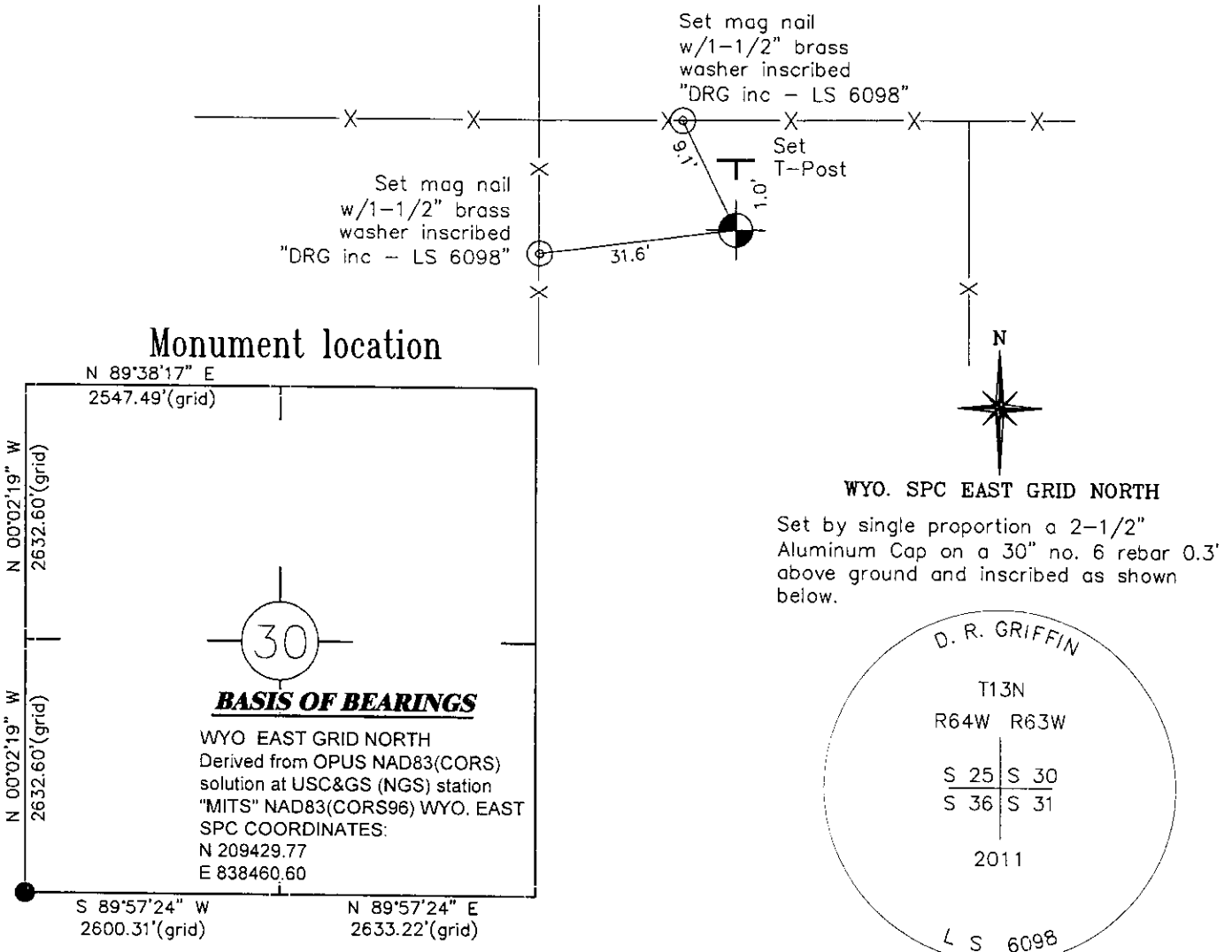

U.S.G.L.O. 1870 Record: Set a limestone 18x7x5 for corner to sections 25, 36, 30 & 31.

No evidence of monument or accessories found. Corner is lost.

Establish corner position by single proportion from the found monument (no. 4 rebar) for the west quarter corner of Section 31 and the found monument (no. 4 rebar) for the northwest corner of Section 30. Set a 2-1/2" Aluminum Cap on a 30" no. 6 rebar 0.3' above ground and inscribed as shown below.

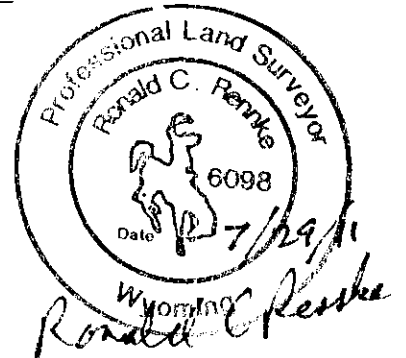
