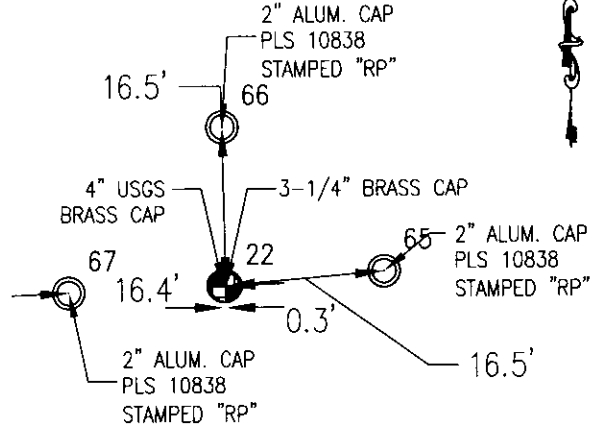

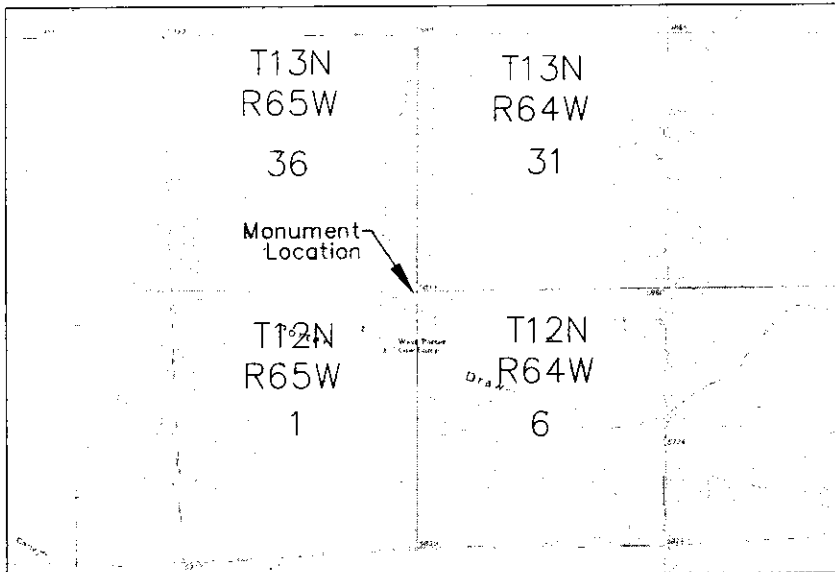

HISTORY: THE ORIGINAL SURVEY OF THE TOWNSHIP LINES WAS PERFORMED IN 1867 BY WILLIAM ASHLEY, STONES WERE SET AS MONUMENTS. A RETRACTMENT OF THE ORIGINAL SURVEY OF THE TOWNSHIP LINES WAS PERFORMED IN 1911-1912 BY EDWIN VAN ANTWERP, AND BRASS CAPS WERE SET AS MONUMENTS, AS SHOWN HEREON. THE PLATS AND ORIGINAL FIELD NOTES OF BOTH SURVEYS WERE OBTAINED FROM THE BLM.

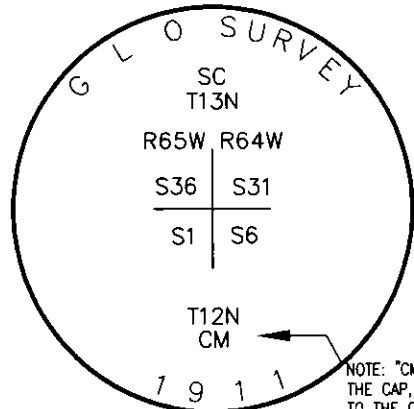

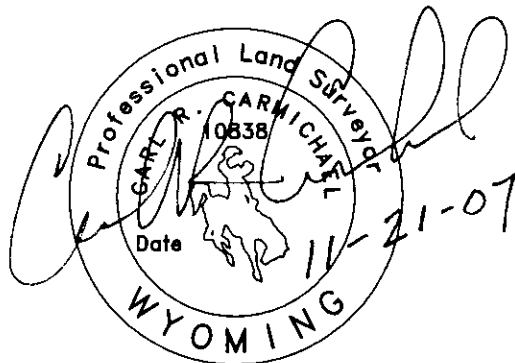
