

DESCRIPTION OF MONUMENT AND ACCESSORIES ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

At the corner: Set $1\frac{1}{2}$ " dia. x 30" long (concrete-filled) iron pipe with brass cap.
Accessories: A $\frac{5}{8}$ " dia. x 24" long rebar with Surv KAP, set on north line of RR R/W bears S $0^{\circ}21'30"$ W, 130.0 feet distant.
 bears N $1^{\circ}10'00"$ E, 16.0 feet distant.
 A 3" dia. x 4' long cedar post with aluminum sign bears S'y, 1 foot distant.


