

**At the corner:** Set  $1\frac{1}{2}$ " dia. x 30" long (concrete-filled) iron pipe with brass cap.  
**Accessories:** A  $\frac{5}{8}$ " dia. x 24" long rebar with Surv KAP, set on north line of RR R/W bears S  $0^{\circ}24'30"$  W, 130.0 feet distant.
