
ORIGINAL RECORD: "SET GRANITE BOULDER 16"x8"x6" FOR 1/4 SEC. COR."

FOUND: FOUND 14"x8"x7" GRANITE STONE, ACCEPTED AS ORIGINAL STONE. ALSO FOUND NO. 4 REBAR ON EAST SIDE OF STONE, 0.6' ABOVE GROUND.


SET: SET THREE (3) REFERENCE TIES AS SHOWN BELOW.


## Monument Location


