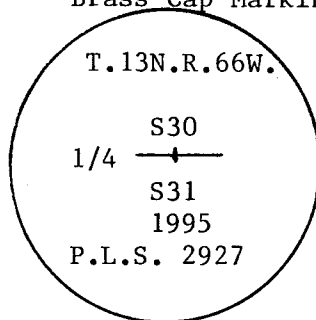
G.L.O. Record: Set Granite Boulder 15" x 7" x 5" for 1/4 Sec. Cor.
Henry G. Hay, U.S. Deputy Surveyor, August 27, 1870.

Subsequent Record: Certified Land Corner Recordation form filed April 6, 1983 by Mr. John A. Steil, Wyoming P.L.S. 2500, indicating found firmly set stone.

Found: Firmly set 12" x 10" x 5" pink colored granite stone with faint + chiseled in top and faintly marked 1/4 on north face.

Set: 2 1/2" x 30" Galvanized Iron Pipe, 26" in the ground with 3 1/4" Brass Cap stamped as noted below. Buried original stone memorial along East side of set monument. Set a 5' steel fence post witness 1' north.

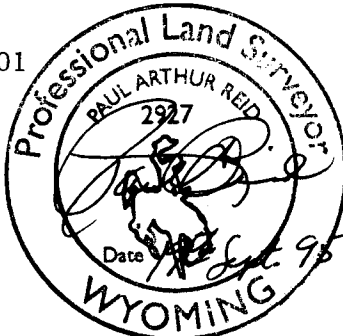
