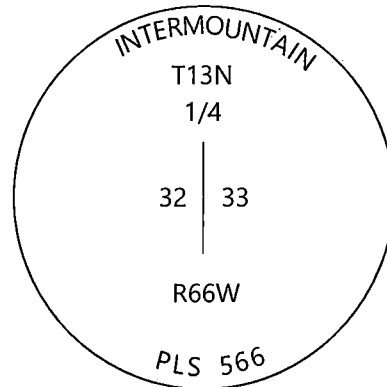
LOCATION: East Quarter of Section 32, T13N, R66W, 6th Principal Meridian, Laramie County.

RECORD: GLO - Set a Granite Boulder 16"x8"x8"

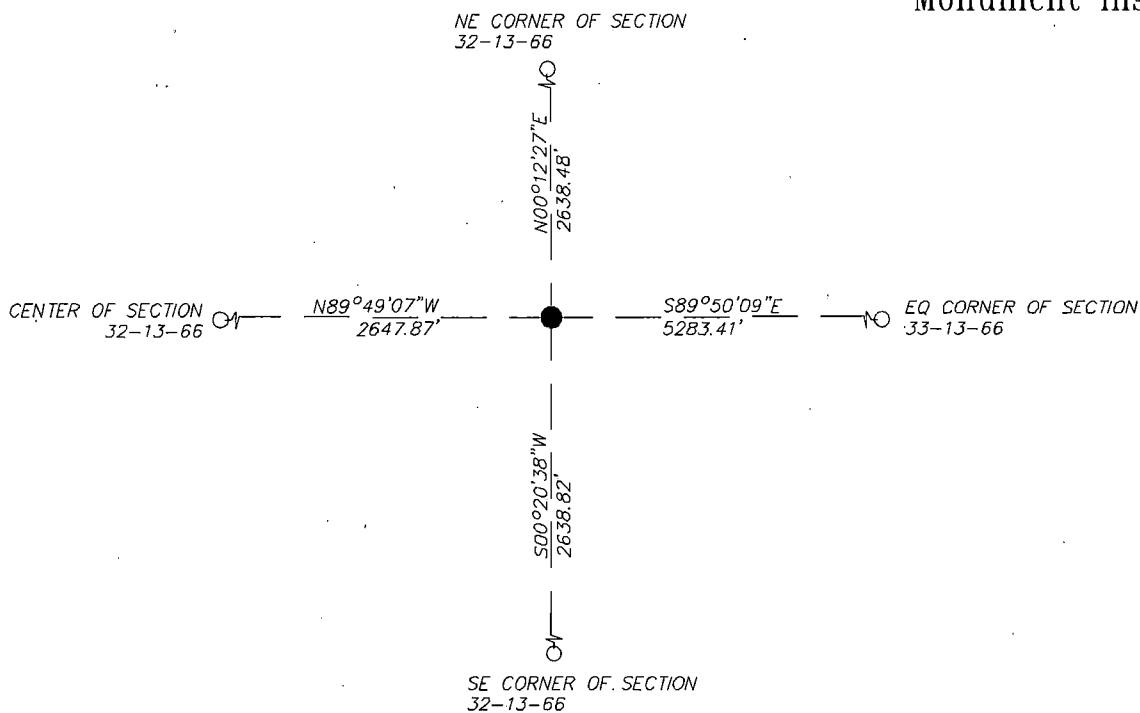
1994 - Terrestrial Surveying & Mapping Co. mentions a 2" iron pipe with aluminum cap at 40.133 chains from the center of section.

RECOVERED: Westwood Professional Services searched area and found a 3.25" aluminum capped monument stamped "PLS 566". Distance matches to adjacent section corners from 1994 survey.

RESET: Holding monument as corner location.
