Surveyors Note: County Roads Book No. 1, circa 1908, presently located in the offices of Laramie County Public Works, does not indicate this corner as being existant at the time of the original survey of Happy Jack Road. From my research of records and field survey which included the evaluation of long time fences in the area, I have found no remaining evidence to declare the corner position obliterated. The proportionate position of this corner from the nearest found and accepted corners east and west indicates this corner to be N35°18'01"W, 1.58 feet from a found W.D.O.T. right of way marker for Happy Jack Road.
