**LOCATION:** North Quarter Corner of Section 18, T13N, R67W, 6th Principal Meridian, Laramie County.

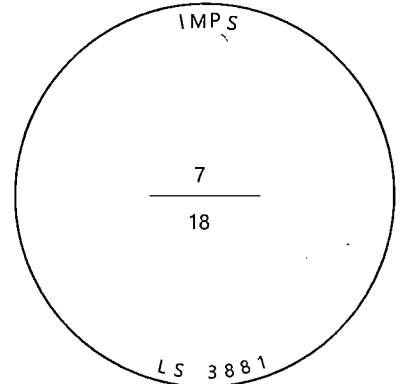
**RECORD:** 1871 - Set granite boulder 16x10x6.

1990 - Becky Braman, LS 3881, files corner record on found pink granite stone, broken in several pieces, under fence. Also found portion with chiseled 1/4 under old flattened can. A 5/8x24" rebar with 2" aluminum cap was set. Fragments of stone were left as memorial.

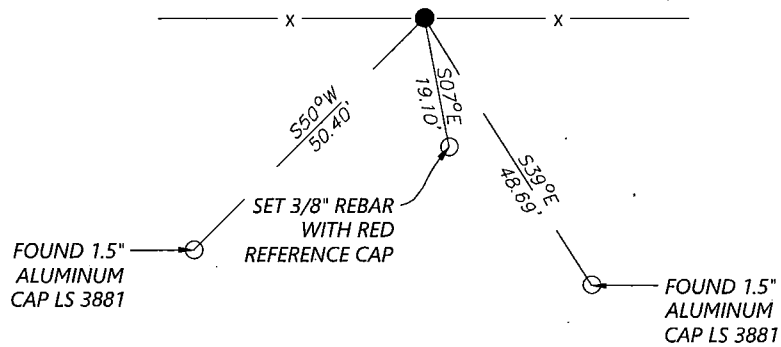
1991 - Donald Hopkins, LS 558, files corner record on found aluminum cap and stone.

**RECOVERED:** 2019 - Westwood field crews recover the aluminum cap as stated in previous corner records. Also found references set by Braman in 1990.

**RESET:** Accepting location of monument as the location of the corner. Set additional tie as shown.
