

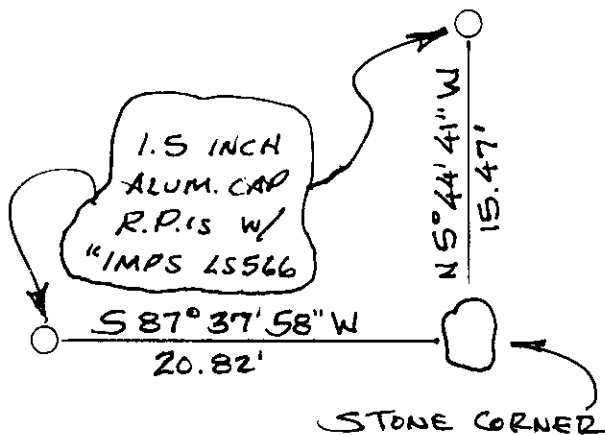

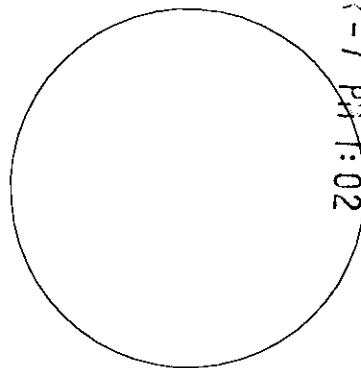
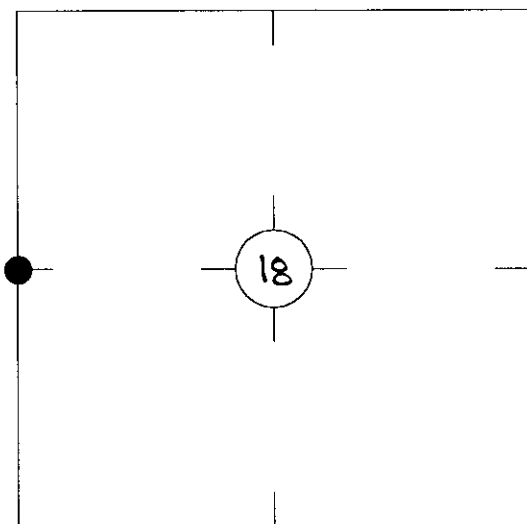
BLACK METAMORPHIC STONE
