Found: A loose set Granite stone, 19" x 9" x 8" out of the ground, in a old earthen mound. Stone was marked with a 1/4 on the West face. Reset the Granite Stone in N/S orientation in original position. Drove a No. 5 x 24" rebar flush to the ground along the east edge of the stone as a memorial.

Set: No. 5 x 24" rebar memorial as noted above.

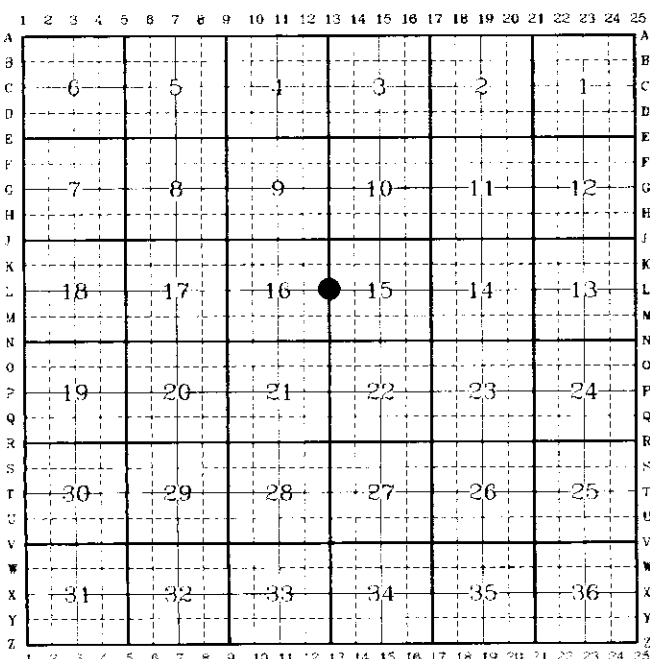
Basis of Bearings and Distances for the ties below were derived with the utilization of the Trimble RTK GPS system and a in the field calibration based upon the City of Cheyenne Control Stations from "PORT" to "CLEAR CREEK" being N15°41'10.1"W @ 12946.09', with the geodetic position of "PORT" being held at NAD 83-94 (HARN) being 41°04' 14.67261" Latitude, 104°52'24.94536" Longitude, 6283.99 Height.

CROSS INDEX DIAGRAM

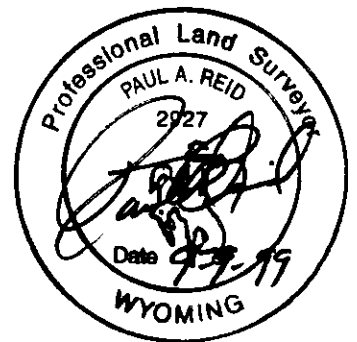
