Set: At the central position of the stone I reset the stone firmly in the ground. Stone was surrounded with a small collar of stones west and south.

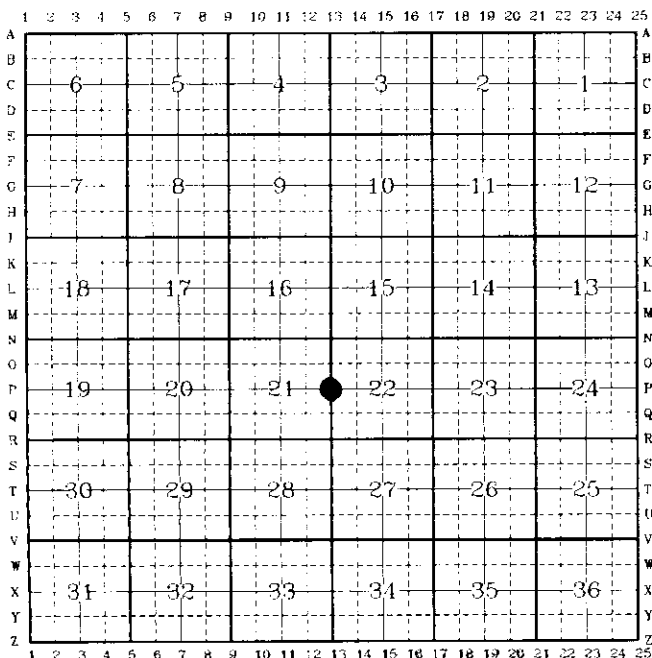
