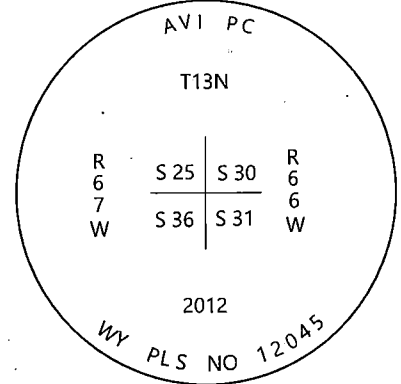
RECORD: 1871 - Boulder 16x11x7.

2012 - Adam Deschler, of A.V.I., set a 3.5" aluminum cap stamped LS 12045 on a 3/4" rebar and 3 ties.

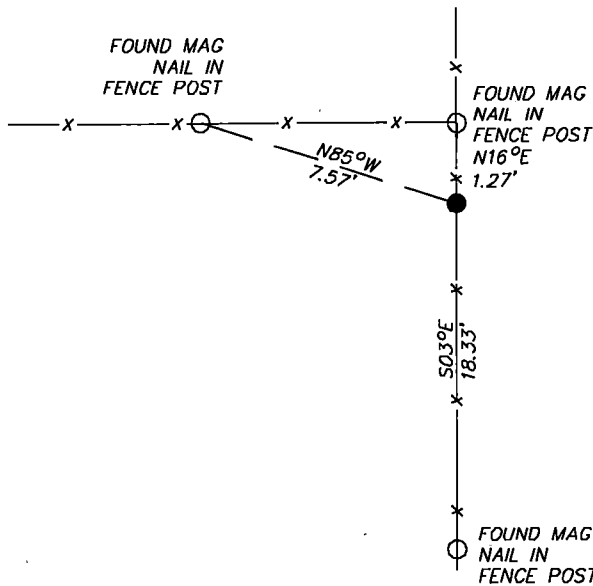
2018 - Albert Valletta Jr., LS 13261, found a 3.25" aluminum cap on a 3/4" rebar and 4 ties.

RECOVERED: 2019 - Westwood field crews found a 3.5" aluminum cap stamped LS 12045 and 3 ties.
