
Set: This corner was reestablished utilizing the State of Wyoming, State Highway Department Plan and Profile Sheets designated as I-25-1(21)2, which indicates a stone was found 24.0 feet south of centerline station 360+58.8. This position appears to be within limits from found original corners north and south and accepted by me as the best available evidence of the original corner position. At the corner point I set a No. 5 x 40" rebar with appropriately marked, per B.L.M. Manual and State of Wyoming requirements, a 2 1/2" Aluminum Cap. Corner monument is approximately 7 East of Westerly edge of the Northbound lanes and approximately 24.5' West of the Easterly edge of the Southbound lanes of I-25.

Basis of Bearings and Distances for the ties below were derived with the utilization of the Trimble RTK GPS system and a in the field calibration based upon the City of Cheyenne Control Stations from "PORT" to "CLEAR CREEK" being N15°41'10.1"W @ 12946.09', with the geodetic position of "PORT" being held at NAD 83-94 (HARN) being 41°04' 14.67261" Latitude, 104°52'24.94536" Longitude, 6283.99 Height.
