LOCATION: Southeast Corner of Section 34, T13N, R67W, 6th Principal Meridian, Laramie County.

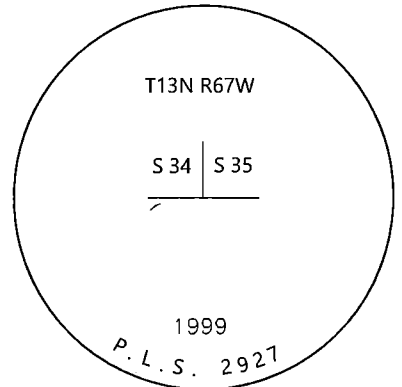
RECORD: GLO - Set granite boulder 16" x 10" x 4"

1998 - Doyle Abrahamson found a 16" x 10" x 4" stone with 2 notches on the east face. He set a steel fence post next to the stone and noted a distance of 5338.48' to the SE 35-T13N-R67W.

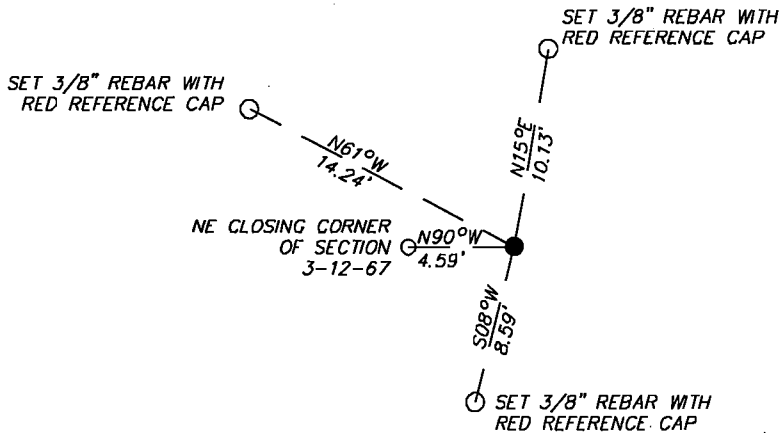
1999 - Paul Reid found a granite stone marked with 2 notches on the east face and 4 notches on the west face. He set a 2.5" x 30" aluminum pipe with a 3.25" aluminum cap stamped LS 2927 in it's place and buried the original stone south of pipe as a memorial.

RECOVERED: 2019 - Westwood Professional Services found a 3.25" aluminum capped monument stamped LS 2927 and witness fence post.

RESET: Accepting location of the monument as the location of the corner. Ties are set as shown.
