**LOCATION:** Northeast Corner of Section 11, T13N, R68W, 6th Principal Meridian, Laramie County.

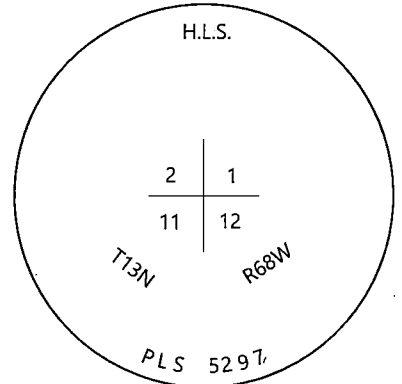
**RECORD:** GLO - Set granite boulder 18" x 10" x 9"

1999 - Chris Hamilton found a marked granite stone laying in pipe along the side of newly constructed fence. He was able to find the hole left by the stone and set a 5/8" rebar with 2" aluminum cap stamped LS 5297 in it's place.

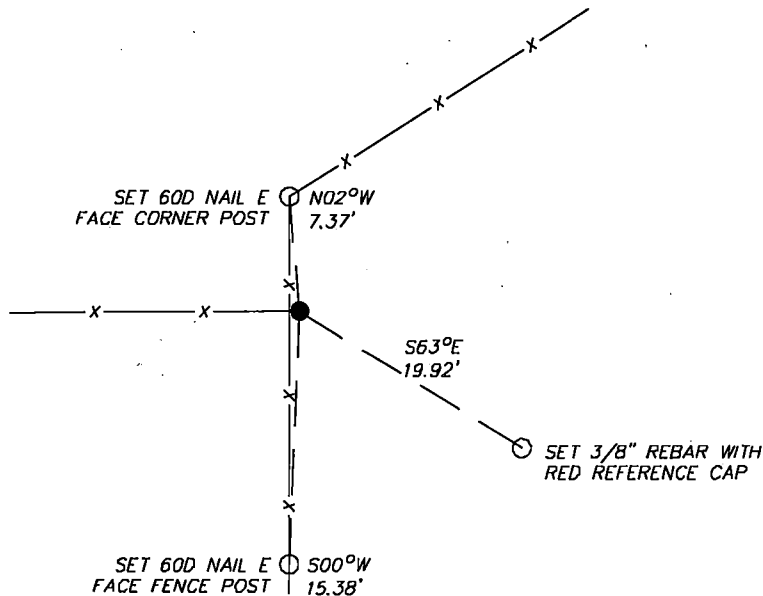
2003 - Daniel Siek found an aluminum cap stamped LS 5297. He notes a distance of 5265.17 to the SE corner of section 11-T13N-R68W.

**RECOVERED:** 2019 - Westwood Professional Services found an aluminum cap at the base of a south, west, northeast fence corner stamped 5297. A marked stone was also found loosely above ground, approximately 1.5' NE of the aluminum cap.

**RESET:** Accepting location of the aluminum cap as the location of the corner. Set ties as shown.
