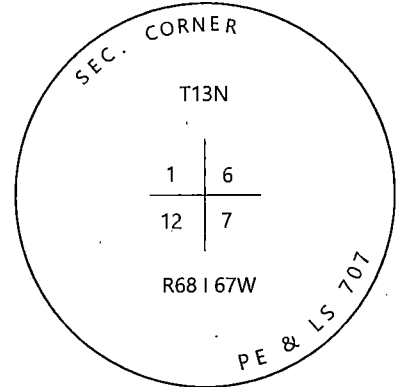

LOCATION: Northeast Corner of Section 12, T13N, R68W, 6th Principal Meridian, Laramie County.

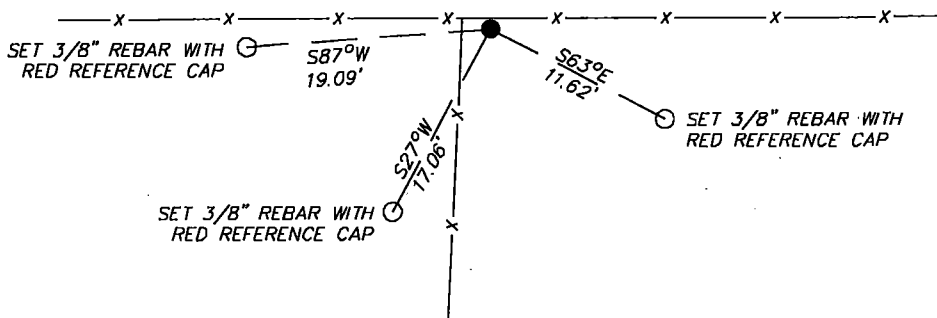
RECORD: GLO - Set granite boulder 24" x 11" x 5"

RECOVERED: 2019 - Westwood Professional Services found a 2" aluminum cap 4' east of a south, east, and west fence corner stamped LS 707. A 20" x 10" x 4" marked stone was also found loosely above ground, approximately 1.2' E of the aluminum cap.

RESET: Accepting location of the monument as the location of the corner. Set ties as shown.

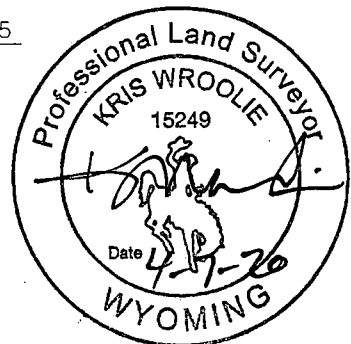
