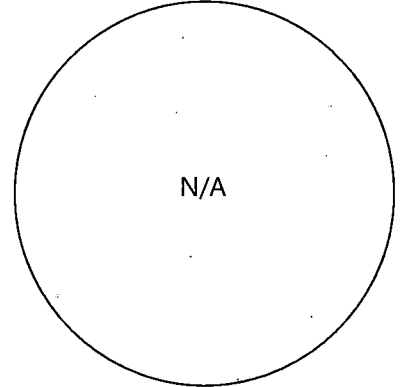
RECORD: 1871 - Set granite boulder 16x9x7.

1991 - William Braman, LS 566, files corner record on found white corner stone with 1/4 chiseled on west side. Also found a 1" iron pipe 0.7' north of the stone.

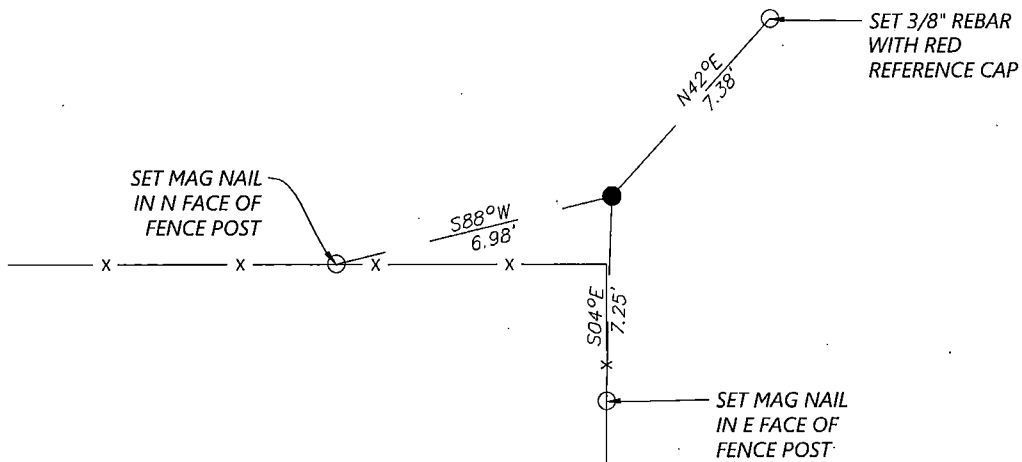
2003 - Daniel Siek, LS 2097, files corner record on found granite stone 9x7 at fence corner with 1/4 on west face and iron pipe on north side.

RECOVERED: 2019 - Westwood field crews recover the granite stone and pipe as described in previous corner records. Did not find the reference ties set by Braman in 1991.

RESET: Accepting location of stone as the location of the corner. Set ties as shown.

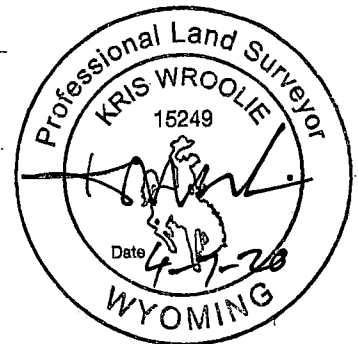
