LOCATION: Northeast Corner of Section 24, T13N, R68W, 6th Principal Meridian, Laramie County.

RECORD: 1871 - Set granite boulder 18x9x7.

1990 - Jeffrey Jones, LS 5910, files corner record on found 3" iron pipe with brass cap marked with marker. No LS number and origin unknown. Also found stone with markings lying next to pipe.

1991 - Donald Hopkins, LS 558, files corner record on found marked stone. Buried stone and set 2 1/2" pipe and brass cap.

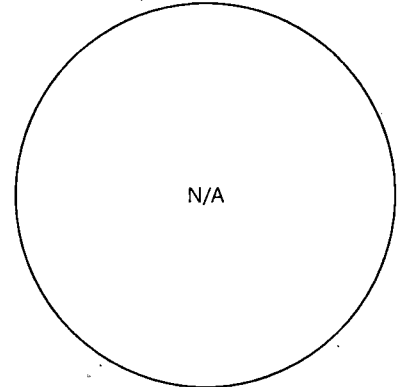
1994 - Robert Coffey, LS 4822, files corner record on found 2" brass cap in north/south fence line with no marking on cap. A pink granite stone lying on its side next to brass cap.

1998 - Chris Hamilton, LS 5297, files corner record on found 2.5" brass cap on 2" iron pipe. A 20x10x7 granite stone is loose at the base of the pipe. Brass cap is not marked with a LS number.

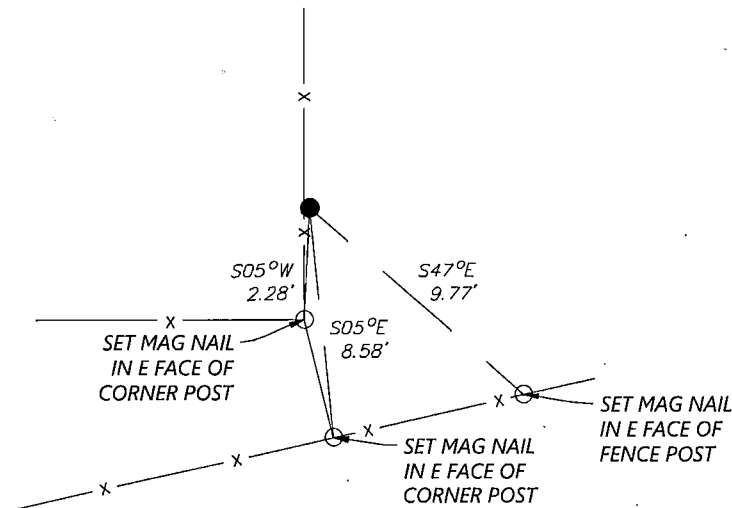
2004 - Daniel Siek, LS 2097, files corner record on found brass cap.

RECOVERED: 2019 - Westwood field crews recover a brass cap and stone as described in previous corner records.

RESET: Accepting location of the brass cap as the location of the corner. Set ties as shown.
