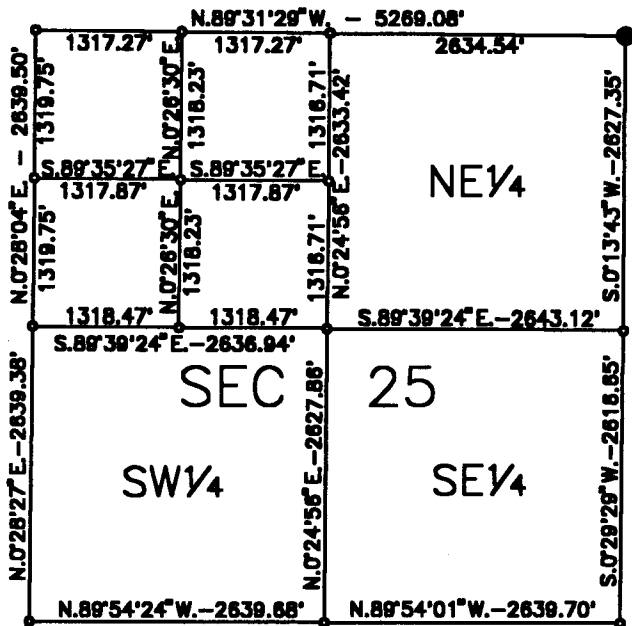

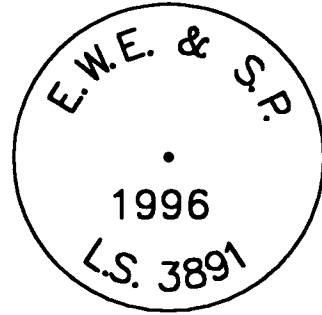

Found 2" aluminum cap on 1" pipe, 6" above ground surface, inscribed and located as shown below.

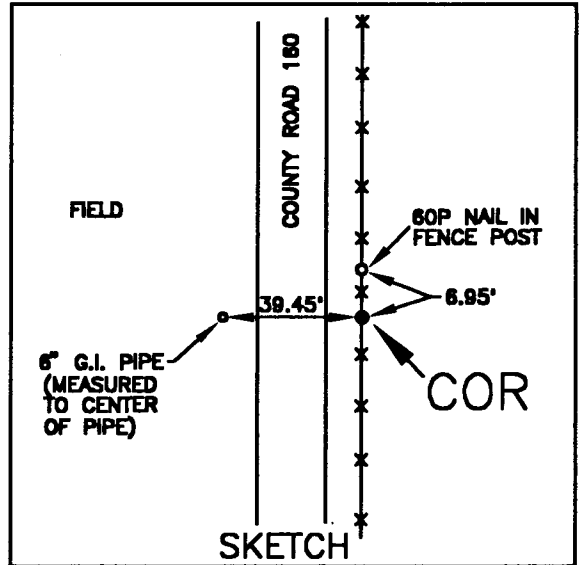

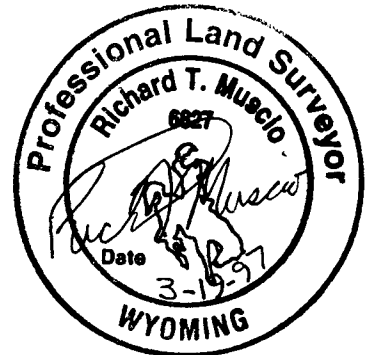
