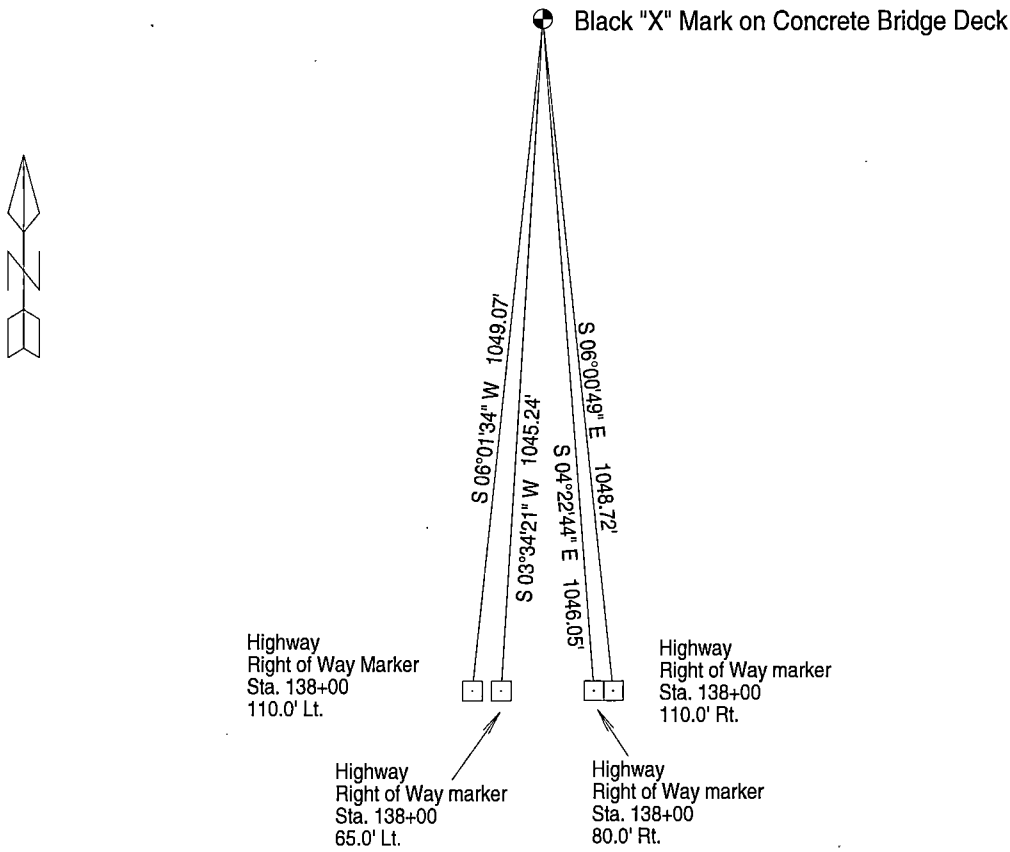

FOUND 3-1/4" dia, Brass Cap on a 2-1/2" dia. iron pipe, 6" out of the ground set by E. P. Kelly and Assoc. in 1970.
Corner Record filed by Paul A. Reid on Feb. 27, 2003. The Brass Cap was removed for the construction of the new bridge over the Union Pacific Railroad.

SET Black Mark on concrete bridge deck. The occupation of this point, roughly in the center line of the bridge deck would not be safe, witness points were referenced to the south.
