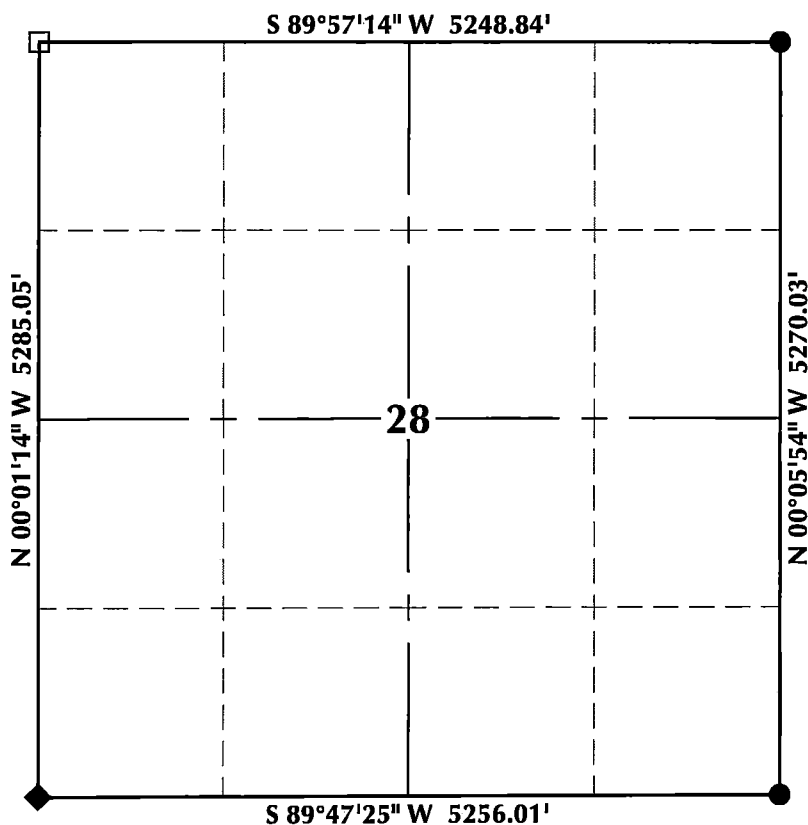

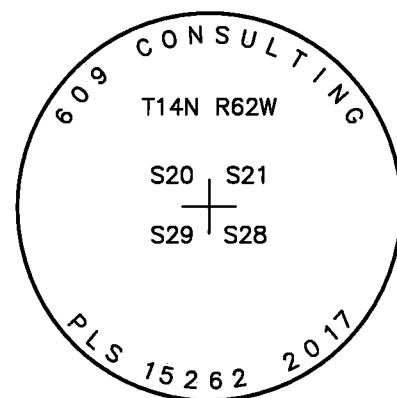
**FOUND:** Concrete highway monument.

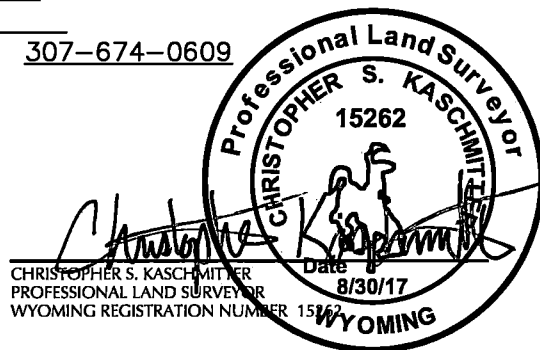
